It has emerged as the premier Institute of Design, Management and Technology, developing professionals for taking up leadership positions in fashion business in the emerging global scenario. NIFT has been granted statutory status under the Act of Parliament of India in 2006, empowering the Institute to award degrees and other academic distinctions. NIFT, Hyderabad Center is situated at Hitech city, Madhapur, Hyderabad.

#### **GENERAL TERMS AND CONDITION**

- 1. Tender shall be submitted in official tender form only. If submitted in any other form shall be summarily rejected.
- 2. The schedule issued with the form of tender listing the details of items to be supplied must not be altered by the tenderer. Any modifications / alterations of the schedule considered necessary by the tenderer should be in the separate letter accompanying the tender.
- 3. No paper shall be detached from the tender.
- 4. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein; otherwise the tender is liable to be ignored.
- 5. The tender is liable to be rejected if complete information is not given there-in, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in.
- 6. Individual signing the tender or other documents connected with the tender must specify whether he / she signs as
  - (i) A sole proprietor of the concern or constituted attorney of such sole proprietor.
  - (ii) A partner of the firm if it is a partnership firm, in which case he / she must have authority to execute contracts on behalf of the firm and refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firms.
  - (iii) Director or Principal Officer duly authorized by the Board of Directors of the company.
  - (iv) In case of (ii) a copy of the partnership agreement or general power of Attorney, in either case attested by a Notary Public should be furnished or an affidavit on stamp paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney should be furnished. The attested copy of the certificate of registration of firm should be attached along with the tender papers. In case of partnership firm, where no authority to refer dispute concerning the business of the partnership has been conferred on any partner, the tender and all other related documents must be signed by all the partners of the firm. In case of (iii) the person signing the tender should be authorized by a resolution passed by the Board of Directors and a copy of the resolution attested by the Principal Officer should be attached.

- 7. The tender must be addressed to the Director, National Institute of Fashion Technology, NIFT Campus, Opp. Hi-Tech City, Madhapur, Cyberabad, Hyderabad 500081 and be deposited in the Tender Box placed in Building Department at NIFT Campus, Hyderabad on or before 2.00 PM on 07.02.2023. The tenders will be opened on 07.03.2023 at 3:00 P.M. in NIFT Campus, Hyderabad in the presence of such tenderers who may wish to be present, either by themselves or through their authorized representatives.
- 8. Tenders must be accompanied with Earnest Money Deposit (EMD) of `11,000/- (Rupees Leven thousand only) in shape of Demand Draft in favour of NIFT, Hyderabad along with their Technical Bid. Technical Bid received without earnest money or with earnest money less than the amount specified above shall be summarily rejected. Tenderers are advised to go through the Earnest Money clause (Annexure "A") attached with this Tender Enquiry carefully before filling the tenders.
- 9. The bids should be valid in the case of all the tenders for at least 6 months from the date of opening of the tender. In the case of the successful tenderer, rates quoted shall be valid for the entire period till the supplies are completed.
- 10. Correction if any must be attested.
- 11. Late tenders will not be considered. (i.e. tenders received after the specified time of opening), delayed tenders (i.e. tenders received before the time of opening but after the due date and time of receipt tenders) and post tender offers will not be considered under any circumstances.
- 12. National Institute of Fashion Technology reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the price bid.
- 13. NIFT shall in no way be responsible for any default with regard to any statutory obligation and the supplier will indemnify NIFT in case of any damage or liability, which may arise on account of action of the supplier.
- 14. Dispute, if any, arising out of the supply, the final decision of the Centre Director will be binding to the supplier. Court jurisdiction will be subject to Hyderabad only.
- 15. Tender shall be accompanied by the relevant documents including "A list of organizations where the supplier has currently provided/has supplied the items covered in the tender".
- 16. As per NIFT policy, payments and receipts to Government and Semi Government Agencies would be rounded off to the nearest higher rupee and in other cases the rounding off will be to nearest i.e. paise 50 or above will be rounded off to the near higher rupee and paise less than 50 will be ignored.
- 17. In case L-1 is more than one, then the Technical qualification of the Tenderer will be the criteria and the decision of NIFT will be final.
- 18. The contract once awarded can be terminated by either party after giving due notice to other party. Nevertheless NIFT may terminate the contract without any notice if the contractor commits a breach of any of the terms of the contract. NIFT decision that a breach has occurred will be final and shall be accepted without demur of the contract.

- 19. The schedule of work is mentioned in the financial bid and the evaluation of bid will be on the basis of total bid value. The rates quoted should be inclusive of all taxes. The rates quoted should be on the basis of free delivery to the consignee.
- 20. The bidders before quoting should visit the site. The list of AC units (Split) and Water Coolers with all details is available with concerned engineer at NIFT Hyderabad. The bidder should check the details before quoting. The site can be inspected from 10AM to 5PM during working hours on any working days. No extra shall be payable for non-awareness and constraints
- 21. The rates quoted should be on FIRM & FIXED basis inclusive of tax.
- 22. The agency shall ensure that he himself or his authorized representative is available for proper servicing at NIFT Hyderabad.
- 23. The agreement will be valid for Preventive / Comprehensive AMC for ACs & Water Coolers as incorporated in the tender document. This should be strictly adhered to.
- 24. The service engineer / technician shall visit once in a month on mutually agree date for general check-up and preventive maintenance.
- 25. The agency has to take up the quarterly service of the ACs and Water Coolers by the qualified / trained personnel.
- 26. Water and power shall be made available free of cost for bonafied use.
- 27. The staff of the agency should carry a valid ID proof before entering into the campus which is required at the NIFT entrance for security check.
- 28. No security will be provided by NIFT to the agency's equipment, tools, spares etc. which is brought into the NIFT premises. The agency should make their own arrangement for security of their materials.
- 29. The successful bidder must maintain all the ACs & Water Coolers in good working condition. On failure of any machine the break-down maintenance should be carried out immediately.
- 30. A penalty of `1000/- will be imposed if the minor fault is not completed within 24 hours, `2,000/- will be imposed if the major fault is not completed within 48 hours. If the equipment is not repaired within 48 hours, the same will be repaired by NIFT from OEM / open market for which the actual cost will be recovered from the agency.
- 31. Any spare parts required for the repair of the AC & Water Coolers are to be borne by the agency. No extra cost will be paid.
- 32. The material utilized should be New and Unused.
- 33. The materials / spare parts used for replacement should be of the OEM / standard manufacturers and of genuine quality. The item should be approved by NIFT / user department. After replacing the new spares the old dismantled parts shall be the property of the agency.
- 34. Minimum stock of spares will be maintained at NIFT premises for immediate exigencies.
- 35. The contractor shall maintain registers i.e. complaint / feedback / performance report.

- 36. After completion of the contract the agency has to handover all the equipments in good running condition.
- 37. Any equipment is lost while in the custody of the contractor or damaged for any reason the contractor is liable to pay the full cost of the equipment as per the prevailing market rate.
- 38. The agency should not remove / dis-locate the existing equipment or its parts without permission of the authorized NIFT officials.
- 39. The agency should enclose client list for the items quoted for & supplied by them during the last 2 years along with the copies of purchase orders.
- 40. They should be registered for GST and Income Tax and should enclose copies of relevant certificates.
- 41. The successful bidder shall deposit 5% of the total cost quoted as Security Deposit to NIFT, Hyderabad within one week after entering into agreement. It shall be furnished in the form of DD in favour of NIFT payable at Hyderabad. No interest shall be paid on security deposit which will be returned after successful completion of contract period i.e. one year from the date of agreement and after adjusting dues, if any.
- 42. The quantity may vary as per the final requirement. NIFT reserves the rights to include or exclude any number of ACs / Water Coolers into / from the contract at any time.
- 43. The contractor shall execute the agreement before taking the contract, agreeing to abide by all the terms & conditions mentioned thereon.
- 44. The payment shall be made against completion of the servicing on the basis of certification by the concerned user department by quarterly / half yearly and against of submission of original Invoice & Service Reports.
- 45. TDS will be deducted as per the prevailing rate and PAN number of the agency to be furnished.
- 46. All bidders are required to submit their offer in two covers (i.e. Envelope-I is Technical Bid and Envelope-II is Financial Bid & the two covers should thereafter, be kept in a third cover and sealed. This cover should also be super-scribed with the (TENDER for Comprehensive AMC of ACs & Water Coolers) and should be addressed to the Director, NIFT, Madhapur, Hyderabad-500081 and be deposited in the Tender Box available at Building Section, NIFT, Madhapur, Hyderabad before 2.00 PM on 07.03.2023.
