**CONDITIONS:**

1. The quoted rates shall include all taxes, duties, GST etc. as applicable & delivery at site and no extra shall be payable on this account.
2. Rates shall be valid for 45 days.
3. The agency / contractor must enclose GST Registration certificate.
4. The agency / contractor should have experience in similar supplies/works. Previous Supply Order Copies may be enclosed.
5. If the supply is not done as per the schedule, penalty equivalent to 0.5% (half percent) of the value of work will be levied per week upto a maximum of 10% of the supply order value in the event of failure of supply within the stipulated time.
6. The payment shall be made on the submission of bill, as per actual required specifications and after successful supply and certification by the concerned.
7. The minimum requirement of the Flat Knitting (2.5 Gauge) 40 inch is 1 Nos. and may be increased /decreased depending upon the quotes provided.
8. The total supply to be completed within 21 days from the date of release of supply order.
