This consent form will provide specific details about the research being undertaken wherein you are requested to participate. It is the right of the participants to ask for any clarification or information on the proposed research from people on site or the ones mentioned on the form. A copy of this consent form will be provided for future reference and documentation.

Background about this research study of INDIAsize -National Institute of Fashion Technology (NIFT), New Delhi under the aegis of Ministry of Textiles, Govt. of India, is undertaking an extensive research study to develop a comprehensive size chart for ready to wear industry based on these body measurements of the Indian population. This is a scientific exercise where anthropometric data will be collected from a sample population in the age group 15 to 65 years and above. It involves scanning of participants in scan suits using human safe 3D whole body scanner technology to extract anthropometric measurements of body Besides that demographic data will also be collected for analyzing the collected data.

Purpose and benefits of this study-This study aims to undertake its own anthropometric survey to take care of the disparities and inconsistencies in apparel sizing systems and to provide better fits in the garments. The proposed study aims at standardizing the apparel size charts(ready made garments) for the Indian apparel sector. Apart from apparel, the findings of the study will have ramifications across various sectors such as automotive, aerospace, fitness & sport, art, computer gaming etc. where the insights from this data can produce ergonomically designed products which are well suited for the Indian population

Time and Activity - Participant who agrees to take part will be asked to

- 1) Go over an initial introduction of the survey with the operator and be assigned a scan ID (5 minutes),
- 2) Read and complete the consent form for agreeing to participate in the study (5 minutes),
- 3) Complete a socio demographic questionnaire which have set of compulsory and optional questions and it is choice of participant to answer optional questions though it is requested that participants answer as many questions as possible (maximum 10minutes),
- 4) Some may be measured manually with a tape measure (for girth) and a stadiometer (for height) Overall six body measurements will be taken by the operator (5 minutes), and
- 5) Change in the scanning suit in the dressing room attached to the body scanner and be body scanned in two postures (1 seating and 1 standing postures) in the scanning garments (15 minutes).
- 6) Changing back into original clothes and collecting of thank you note before leaving (5 minutes)

The scanning garments consist of scan suits- (upper and lowers). In case of them not wearing appropriate inner wear, appropriate inner garment to ensure the accuracy of the body measurements shall be provided. The provided garments are assured to be new and will be given away as souvenir. The scanner uses Depth sensor technology that poses no risk to your health will be used to scan the participant. The total time taken for above listed activities is 45 minutes.

Risks-There is minimal risks during this scan. The Size Stream 3D body scanner has been thoroughly evaluated and deemed harmless. Safety certificate is available with the site manager and can be checked on request before signing the consent form.

Confidentiality-The personal information collected during the study will be kept confidential to the full extent and will never be shared. The scanned data will be stored only in Government approved cloud services. Data will be stored securely in locked files. No reference will be made of the participants name or identification in any oral or written reports to maintain privacy. The information collected as part of the project shall not be used for any commercial

purpose and will only be used for purpose defined in the scope of the project.

Apart from that participant will be getting voucher of Rs.500/- as a gift for participating in the survey which will be given only after completion of the full process.
