4. - b. If selected bidder supplies sub-standard materials.

The firms who are registered with National Small Industries Corporation (NSIC) / OR Small Scale Industrial (SSI) are exempted to submit the EMD (Copy of registration must be provided along with).

If financial bid received without EMD Fee the same will be rejected. In the event of non performance of the job the EMD will be forfeited.

- **5.** In the event of unsatisfactory services rendered by the contractor, monetary fine as penalty @ Rs. 1000/- per day will be imposed for every default during the period of event.
