# 1. Introduction:-

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raibareli, Shillong and Srinagar.

National Institute of Fashion Technology (NIFT) was set up in 1986 under the aegis of Ministry of Textiles, Government of India. It has emerged as the premier Institute of Design, Management & Technology. NIFT Jodhpur was established in 2010.

NIFT, Jodhpur invites Expression of Interest (EOI) for hiring of building for hostel accommodation for 50 -100 students (For Boys & Girls) located in and around NIFT, Jodhpur, as per following details:

- 1. Separate students hostel for approx. Girls (50 to 100) and Boys (50-100).
- 2. Dining Hall with kitchen space.

**Location:** Suitable area under preferably within 15-25 Km radius of NIFT Campus, Karwar, Jodhpur-342037, Rajasthan, India

### 2. <u>Process for Submission of EOI:-</u>

(a) The interested firms/parties should apply online and submit their EOI and the bids along with scanned copies of all the relevant certificates, documents, etc. in support of their technical bids – all duly signed – on the https://nifttenders.eproc.in from **18/05/2019 to 10/06/2019 up to 2.00 P.M**. EOI documents is also available for viewing on the "EOI" link of the NIFT website i.e. https://nifttenders.eproc.in

(b) Applications to this EOI will be accepted only through the online mode through the website https://nifttenders.eproc.in. No other mode of application will be considered & application will not be accepted. However, the firm should submit application/document as described in clause No. (d)

(c) For applying online, the Firm should get itself registered at https://nifttenders.eproc.in by paying:-

• Registration Charges of Rs. 2000/- + Rs. 360/- (Inclusive GST) = Rs2,360/- (Two Thousand Three Hundred and Sixty Only - non-refundable) and Bid Processing Fee charge **(inclusive of GST)** (non-refundable) through online payments will be paid by technically shortlisted parties through e-tendering.

(d)The Firm should ensure that it complies with the requirements as per works before applying for EOI. Also, the interested firms should submit a hard copy of the application submitted online with all relevant supporting documents by **10/06/2019 up to 2.00 P.M.** Non-submission of hardcopy as directed will lead to rejection of the EOI application.

(e) The sealed hard copy of the EOI shall be submitted in one big envelope superscripting "Expression of Interest (EOI) for hiring of building for hostel accommodation" containing separately sealed envelope, one and addressed to The Purchase Officer, National Institute Of Fashion Technology, NIFT Campus, Jodhpur. The hard copies of sealed EOI's documents must be dropped in the box kept at Reception Area NIFT Jodhpur, on or before 10/06/2019 up to 2.00.

(f) The technical bid will be opened at NIFT, Jodhpur on **10/06/2019 up to 3.00 P.M.** in the presence of the bidders/ their authorized representatives who wish to be present.

(h) The interested firms are advised to read carefully the entire EOI document before submitting their EOI and the EOI documents not received online in prescribed format and/or are found incomplete in any respect shall be summarily rejected.

- C. The premises on offer will be shortlisted on the basis requirements of the NIFT Jodhpur and report of the committee. Exact rates will be invited from the shortlisted parties through e-tendering.
- D. NIFT Jodhpur reserves the right to reject all the offers without giving any reasons.

The offers are to be submitted to the Purchase Department, NIFT Campus , Karwar, Jodhpur-342037, Rajasthan, India in sealed envelope superscribed "Expression of Interest (EOI) for hiring of building for hostel accommodation" on or before 10/06/2019 (02:00 PM) and all the offers will be opened on the same date at 03:00 PM.

#### 3 - Inspection/Visit of locations:

NIFT, Jodhpur shall have the right to inspect the location & premises to check the suitability of the premises for NIFT, Jodhpur Hostel along with technical criteria (Annexure A).

#### 4- <u>Amendment to EOI:</u>

At any time prior to the last date of submission of EOI's, NIFT may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidders, modify the EOI document by issuing corrigendum/addendum.
