1. INTRODUCTION:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raibareli, Shillong and Srinagar.

National Institute of Fashion Technology (NIFT) was set up in 1986 under the aegis of Ministry of Textiles, Government of India. It has emerged as the premier Institute of Design, Management & Technology. NIFT Jodhpur was established in 2010. NIFT, Jodhpur invites sealed tenders for Supply of Fashion Communication (FC) Lab Equipment at NIFT Campus Karwar, Jodhpur.

2. Submission of Bids

- (b) Applications to this tender will be accepted only through the online mode through the website https://nifttenders.eproc.in. No other mode of application will be considered & application will not be accepted. However, the firm should submit application/document as described in clause No. (d)
- (c) For applying online, the Firm should get itself registered at https://nifttenders.eproc.in by paying:-
- Registration Charges of **Rs. 2000/- + Rs-360/-** (Inclusive GST) = Rs2,360/- (Two Thousand Three Hundred and Sixty Only non-refundable).

- (d)The Firm should ensure that it complies with the requirements as per works before applying for tender. Bids received shall be evaluated as per the Criteria prescribed in the tender document. NIFT will not entertain any modifications subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respects as per requirement of tender document specifying their acceptance to all the clauses of Bid Evaluation Criteria, General terms and conditions and compliance to the Scope of Work requirement etc.

The EMD draft should be kept in the Technical Bid Cover. The Technical bid and the financial bid should be sealed by the tenderer in separate covers duly super scribed as "Technical Bid" and "Financial Bid" respectively. - **4. INSTRUCTIONS TO TENDERERS:** The tenderers are requested to follow the below mentioned instructions:
 - 1. Offers on original tender document will only be considered. Offers submitted by fax or in any manner other than specified above shall not be considered. The bids shall exactly be according to the prescribed formats. Modifications/Rewording of formats shall not be acceptable.
 - 2. All documentations are required to be in Hindi/English.
 - 3. Tender should be filled with neat legible and correct entries. Indistinct figures, erasures and alterations are not permitted in the tender.
 - 4. Failure to comply with these conditions will result in forfeiting of the tender. Please cross out any mistakes and rewrite the same and counter sign.
 - 5. Incomplete tenders, amendments and additions to tender after opening and tenders submitted after due date shall liable to be ignored.

- 6. Cost involved in submitting the bids, attending the tender opening meet arrangements for the demonstration /presentation etc. shall be borne by the bidder
- 7. Tender shall be accompanied by the relevant documents including the following:

 - e)Authorization letter of the OEM(Original Equipment Manufacturer)
- 8. No tenderer shall be allowed to withdraw the tender rates after opening of the tender. If any tenderer withdraws the rates the EMD amount deposited by him shall be forfeited and he shall be disqualified from participating in any future tender of the Institute.
- 9. No interest shall be paid on the EMD and the EMD shall be forfeited in case the selected/successful bidder does not accept the W.O. or unable to supply goods.
- 10. Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.
- 11. Warranty/guarantee :- as per company policy.
- 12. The defective goods shall be replaced by the agency without any additional charge during guarantee period of supplied goods. The replacement shall have to be carried out within 7 days of the intimation being received from the Institute.
- 13. Tenderer shall have to quote item wise rates, consolidated rates shall not be considered and tender shall be liable to be rejected out rightly.
- 14.NIFT Jodhpur reserves the right to change the quantity/ upgrade the criteria/ drop any item or part thereof/extension of delivery date at any time before placing the purchase order.
- 15.NIFT Jodhpur may increase/decrease total no. of above mentioned articles/goods if required.

5. TERMS AND CONDITIONS:

- a) **Validity of the Offer**: The offer should be valid for three months from the date of opening of Financial Bid; it can be further extended for the period of three months.
- b) **Right of Acceptance:** NIFT does not bind itself to accept the lowest tender. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order at the sole discretion of NIFT.
- c) **Delivery:** The items(**Fashion Communication (FC) Lab Equipment**) should be delivered, placed, installed and commissioned at NIFT Campus, (NIFT Campus, Karwar, Jodhpur- 342037, Rajasthan, India.) within a period of 15 days from date of issue of letter of award.

If the tenderer fails to supply the ordered quantity within the stipulated time period/supplies sub-standard item, liquidated damages equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goods.

- d) **Responsibilities:** The furniture items supplied should be brand new furniture and should be installed/commissioned at the locations specified by NIFT at no extra cost to NIFT. NIFT is not bound to provide any mode of transport in respect of men or material required for the contract.
- e) **Prices:** The vendors are required to quote as per "Annexure II" (Financial Bid). The Bidder shall quote the rates in figures as well as words. The figures should be clearly written and there should be no overwriting. The rates quoted shall include the cost of material, labour, T&P etc, as required for the completion of work. The quoted rates shall be inclusive of all taxes, duties, Goods and Service Tax (GST) etc. as applicable and no extra shall be payable on this account.
- f) Payment Terms: No payment shall be made in advance.

Full Payment shall be released after the successful installation of the ordered goods against the submission of the Inspection report by the committee, In case of any delayed payments to the vendor due to unforeseen reasons, no interest or payment over and above the payment due will be made by NIFT to the vendor.

TDS as per rule shall be deducted from the bills of the contractor. The agency must enclose copy of PAN No. supported by copy of PAN Card of the company.

- g) Signing of Tender: The individual signing the tender (or the documents in connection with it) must specify whether he/she is signing as:
 - 1. A sole proprietor of the firm, or constituted attorney of such a proprietor.
 - 2. A partner of the firm, if it be a partnership, in which case he/she must have the authority to refer to arbitration, disputes if any, concerning the business of the partnership. Either by virtue of the partnership agreement or power of attorney.
 - 3. Authorized signatory of the firm, if it is a company (a letter of the authority in this respect must be enclosed along with the bid).
 - 4. A person signing the tender form or any part thereof, on behalf of another, shall be deemed to warrant that he/she has the authority to bind the other and if on inquiry it appears that the person so signing has no authority do to so, NIFT may without prejudice to other Civil and Criminal remedies, cancel the contract and hold the signatory liable for all costs and damages.

Each page of the tender form, agreement for purchase and agreement for Supply, Installation and Commissioning should be signed and stamped for the purpose of the tender offer.

- h) General: NIFT reserves the right for any reduction/increase in the scope of work and the same shall be awarded to the vendor at the same Unit Rate mentioned in their bid.
- i) Jurisdiction: All disputes shall be subject to NIFT Jodhpur.

Jurisdiction only. In case of any dispute raised by the supplier, a representation will be made only by the authorized representative of the supplier and the decision of the Director NIFT Jodhpur will be binding on the supplier.

- j) **Performance Security:** The successful tenderer will be required to furnish a Performance Security Deposit of 10% of contract value after receiving Notification of Award in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "**National Institute of Fashion Technology, Jodhpur**" which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.
- k) National Institute of Fashion Technology reserves the right to accept in part or in full or reject any or more quotation(s) without assigning any reasons or cancel the tendering process and reject all quotations at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s) and is not bound to accept the lowest evaluated bid since due weightage shall be given to several factors besides the commercial bid and decision of NIFT to that effect shall be final & binding.
