CIRCULAR

In continuation to NIFT HO letter no. 1400(47)/ Head – AA / Fee structure /2011 dated 22-July-2018 and NIFT Jodhpur Circulars dated 10-August-2019, I am directed to inform that last date of depositing the fees for the session January to June, 2020 is 27th January, 2020. Fee with a late fine of Rs. 100/- per day can be deposited till 7th February, 2020. The name of the student will be struck from the institute rolls without any further notice due to non-payment of fee after the specified dates. As per NIFT Academic Manual after striking off the name of the students from the NIFT rolls due to non payment of fee with or without fine, if the student still wants to continue in NIFT, the student would have to pay a re-registration fee of Rs. 5,000/- over and above the semester fee within the next fifteen calendar days after the notified last day for depositing fee with fine.
