### CIRCULAR

In continuation to NIFT HO vide circular no 1400(47)/Head-AA/Fee Structure/2011 dated 28/07/2020 & 1400(47)/Head-AA/Fee structure/2011 dated 28-08-2020 and in reference to NIFT Jodhpur Circulars 15351(2)/AA/Fee Circular & Office Memorandum/2017 dated 03-08-2020 and email circulations dated 28-8-2020, I am directed to inform that last date of depositing the fees for the session January to June, 2021 is **8<sup>th</sup> February, 2021**. Fee with a late fine of Rs. 100/- per day can be deposited till **19<sup>th</sup> February, 2021**. The name of the student will be struck off from the institute rolls without any further notice due to non-payment of fee after the specified dates. As per NIFT Academic Manual after striking off the name of the students from the NIFT rolls due to non payment of fee with or without fine, if the student still wants to continue in NIFT, the student would have to pay a re-registration fee of Rs. 5,000/- over and above the semester fee within the next fifteen calendar days after the notified last day for depositing fee with fine.

Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact Academic Affair Section of the Campus before the commencement of the session and to complete the formalities. Such students will be required to pay the re-registration fee of **Rs. 10000 + GST as applicable** per absents semester as well as non-refundable annual charges towards Library and Student Development Medi-claim fee besides the above mentioned amount.

**Further, it is to inform to all concerned that the fee for this Semester (January-June 2021) has to be paid in full. The relaxation for paying the fee in installments was approved by the BOG only for the last Semester (July-December 2020).**

**CIRCULAR**

NIFT is committed to academic excellence in fashion education. The vision of the institute embraces challenges and provides the impetus in setting highest academic standards. To meet the above commitment and to be on top, a lot of investment is done in infrastructure and faculty development. NIFT being an autonomous body is self reliant to meet its expenditure on infrastructure, a minimal hike of 10% is kept in the fee on yearly basis to utilize the same for development of best of the art infrastructure and engagement of best available faculty at NIFT and also engagement of Guest Faculty from Industry and from various Institutes across the world. This empowers NIFT to support students from weaker sections of society by grant of Tuition Fee Waivers, Merit Scholarships and study abroad expenses through various schemes such as "Sarthak-means cum merit scholarship", "Merit Scholarship scheme" and "Uddan-Study abroad scheme".

Although, every year NIFT enhances the fee to mitigate the expenses, however, in the situation arisen due to Pandemic in our country and taking into account economic slowdown in the Industry, NIFT has considered the following:

- 1) Tuition fee hike has been reduced by 5% for the Semester July-December, 2020 as per semester mentioned at Annexure-I except for NRI students.
- 2) Further to ease the pressure of lump sum payment, the students will be allowed to pay the fee in 3 installments and also be exempted from late fee fine for this semester.

Based on the above, a revised fee structure for the semester July-December, 2020 and also January-June, 2021 is attached as per the Annexure-I. This is in supersession of the circular no. 1400(47) / Head – AA/ Fee structure / 2011 dated 28th July, 2020.
