For all other students classes will continue Online and they will be informed in advance regarding reopening.

Based on above, all UG -  $6^{th}$  Semesters & PG -  $2^{nd}$  Semester students may plan their travel accordingly. They may reach Jodhpur on 22-February-2021 and settle down in hostels and attend GE classes online. The CCs will inform them the detailed plan for classes on arrival.

Both physical and online modes will be available. Those who are not able to attend/prefer online mode/ have allergic conditions may continue online.
