- 2. Last date of depositing Hostel Fee for all students of BFT & B.Des & MFM (II Sem.) is 28.02.2022
- 3. Students opting for On-line payment (NEFT/RTGS/IMPS) of hostel fee will have to submit payment details in fee challan. (Attached)
- 4. After depositing hostel fee and mess fee, room will be allotted by the hostel warden on submission of fee challan.
- 5. Use of narcotics, smoking, consumption of alcoholic beverages and gambling are strictly prohibited.
- 6. Student will be responsible for the care of the room allotted and furniture provided. No furniture can be removed from the room.
- 7. The Student will not be allowed to stay in hostel due to non-payment of hostel fee & mess fee, after last date of fee deposit.
