- 4. Each Vendor has to certify that all the terms and conditions EOI met as above.
- 5. The unit rate per kg.(inclusive of GST) should be quoted in the prescribed format and total value may be derived on the basis of tentative weight. The quoted amount shall be paid by the successful vendor within 05 days from the date of issue of letter of intent in the form of Demand Draft/Pay order/RTGS/NEFT only payable to the NIFT Jodhpur. No request for change in mode/schedule of payment will be entertained in any case.
- 6. The Files/Tools & Material will be provided to the approved vendor on the basis of approved rate (Per Kg.) on the actual basis.
- 7. The Files/Tools & Material will be lifted by lifted by the contractor from their own arrangement and NIFT will not provide any manpower for this purpose. The stores mentioned above will be disposed of/mutilated by the
