NOTICE INVITING EXPRESSION OF INTEREST FOR CENTRAL / STATE GOVT.ORGANISATION / PSU's TO CARRY OUT CIVIL OR ELECTRICAL WORKS AT

NIFT KANGRA CAMPUS

1. Introduction:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centres. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raibareli, Shillong and Srinagar.

2. Scope of Work

NIFT Kangra has an area of 26 acres of land given by state government and the Campus has come up with beautifully designed buildings.

Being a Govt. Organisation, we are looking for:-

- i). Any Public Sector Undertaking set up by the Central or State Government to carry out civil or electrical works or
- ii). to any other Central/ State Government organisation /PSU which may be notified by the Ministry of Urban Development (MoUD) for such purpose after evaluating their financial strength and technical competence.

For the award of work under this sub-rule, the Ministry/ Department shall ensure competition among such PSUs/ Organisations. This competition shall be essentially on the lump sum service charges to be claimed for execution of work. In exceptional cases, for award of work under (i) and (ii) above, on nomination basis, the conditions

contained in General Financial Rule 194 would apply. The work under these circumstances shall also be awarded only on the basis of lump sum service charge.

The Scope of work:

Construction of various works according to the specifications.

Construction supervision and inspection.

4. ELIGIBILITY CRITERIA OF APPLICANTS

Technical Eligibility Criteria:

- i). Any Public Sector Undertaking set up by the Central or State Government to carry out civil or electrical works or
- ii). Any other Central/ State Government organisation /PSU which may be notified by the Ministry of Urban Development (MoUD) for such purpose after evaluating their financial strength and technical competence.

5. EVALUATION OF THE APPLICATION

- a). The evaluation of the application will be done to establish the capability of the applicant as brought out in para 4.
- b). Applicants are required to submit the relevant information in connection with para 4 in the relevant format only.
- c). The evaluation will be done based on the information furnished by the applicant along with the application and it is not intended to ask any supplementary information. NIFT Kangra however, reserves the right to make enquiries from relevant authorities / parties in relation with the information furnished.

6. AMENDEMENT

NIFT Campus Kangra, may modify the EOI by issuing an addendum before the last date of submission of the Application. Any addendum thus issued shall be part of EOI and shall be communicated in writing to all the prospective bidders who have downloaded the document and shall be available on the websites from which documents can be downloaded. To give Applicants reasonable time to take addendum into account in preparing their Applications, NIFT Kangra may at its sole discretion, extend the last date of submission of Application.

7. GOVERNING LAW

The governing law for the purpose of the concessioning process including this prequalification process is the laws of India and Indian courts shall have full jurisdiction considering any matter arising out of this EOI.

8. RIGHT TO ACCEPT OR REJECT APPLICATION
