- Tuition fee for the 2<sup>nd</sup> semester January-June 2023 (Non NRI students admitted in 2022-23 Academic Year):
- a. The Non–NRI students admitted in 2022-23 Academic Year are required to pay the <u>tuition fee for January-June, 2023 (2<sup>nd</sup> semester)</u> as published in the prospectus 2022 i.e. <u>Rs. 1,36,000/-</u> (One Lakh Thirty Six Thousand Only).
- Fee for NLEA Non-NRI students admitted in 2022-23 Academic Year are required to pay the <u>tuition fee</u> for <u>January-June</u>, 2023 (4<sup>th</sup> semester) as published in the prospectus 2022 i.e. <u>Rs. 1,36,000/-</u> (One Lakh Thirty Six Thousand Only).

The students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration:

- Last date of depositing the fee for July-December, 2022 is 18<sup>th</sup> September, 2022. Fee with a late fine of Rs.100/- per day can be deposited till 2<sup>nd</sup> October, 2022.
- Last date of depositing the fees for the session January to June, 2023 is 15<sup>th</sup> February, 2023. Fee with a late fine of Rs. 100/- per day can be deposited till 28<sup>th</sup> February, 2023.
- The name of the student will be struck from the institute rolls without any further notice in case of nonpayment of fee after the specified date.
- PG students of 3<sup>rd</sup> Semester will be required to pay the Alumni Association Membership Fee (One time) (Non Refundable) of Rs. 5,300/-.
- 5. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their concerned campus before the commencement of the session to complete the formalities. Repeat students will be required to pay the re-registration fee of Rs. 10,000/- + 18% GST = Rs. 1,800/- = Total Rs. 11,800/- per absenting semester as well as non-refundable annual charges towards Library and Student Development, Medi-claim & Exam Fee over and above mentioned amount.
