#### Expression of Interest (EoI) for empanelment of Guest Faculty in NIFT Kangra.

National Institute of Fashion Technology (NIFT) is a premier Institute set up under the Aegis of the Ministry of Textiles, Government of India. The Institute has 16 Campus all over India including NIFT Kangra Campus.

The NIFT Kangra Campus started functioning from August 2009 with the following 5 four year Degree courses:-

- 2) B Des (FC)
- 3) B Des (AD)
- 4) B Des (TD)
- 5) B F Tech

The expression of Interest from qualified subject experts is invited for empanelment of Guest Faculty for Teaching in NIFT Kangra Campus. The Empanelled Guest Faculties will be called for teaching various modules as per the course curriculum of the NIFT and paid honorarium as per the policy of the NIFT as revised from time to time.

Interested persons may send their EOIs through post/by hand, in prescribed format, with self attested copies of experience and Educational Certificate to the undersigned so as to reach on or before 30.11.2018 by 14.00 Hrs. The soft copy of the complete EOI with indicated documents may be sent by e-mail to (Jointdirector.kangra@nift.ac.in) as per the timelines. Applicant should write, õApplication for the guest faculty and department nameö in the subject of email. The applications which are received after the timelines shall not be entertained and will be summarily rejected

The EOI will be evaluated Department Wise as per course curriculum of NIFT available on the website of the NIFT. As per the requirement of NIFT Kangra Campus, the Guest Faculty shall be shortlisted time to time from the empanelled list, and shall be called for teaching specific Module/Subject in specific semester of specific Department. The indicative list of desired qualification is provided in Annexure VII

NIFT Kangra reserves the right to postpone or cancel the complete Empanelment process or modify the criteria or any guidelines mentioned in the EoI at its sole discretion and without assigning any reason, if NIFT Kangra determines that such action is in the best interest of the NIFT

In addition to the above, NIFT Kangra Campus intends to empanel the Guest Faculty for the General Elective Subject for which the details are provided in Annexure VIII. The application form for submitting the EOI is same for both kind of subject. The applicants need to submit only Annexure III to Annexure VI along with EOI.

#### B. Scope of work and requirements of Guest Faculty.

- 1. Guest Faculty will have to follow the course curriculum as per the National Institute of Fashion Technology.
- 2. Guest Faculty should have the requisite qualification, experience to ensure the teaching as per the standards prescribed in the course curriculum.
- 3. Guest Faculty should be available for teaching as per mutually agreed time and venue.
- 4. Guest Faculty may be required to evaluate the students as per the requirement of curriculum and existing examination and evaluation policy of NIFT
- 5. Guest Faculty may be required to mark attendance of the student and evaluate assignment of the student and provide marks.
- 6. The Guest Faculty may be required to be present in evaluation panels, if required.
- 7. Payment of the Guest Faculty shall be released post the completion of all requirement of deliverance and assessment criteria.

#### C. Special Instructions for the Guest Faculties.

- 1. This EoI does not commit NIFT Kangra to award a offer of Teaching or to engage in negotiation. This is for empanelment of eligible Guest Faculties.
- 2. Interested applicant may furnish their EoI through post/hand delivery by giving all the necessary documents in English as specified in formats provided in the EoI.
- 3. —NIFT Kangra reserves the right to withdraw or amend this EoI, without assigning any reasons for the same, if NIFT Kangra determines that such action is in the best interest of the NIFT. NIFT undertakes that all the information shared by the applicant will be strictly confidential and will not be made public unless directed by law.
  - 4. The prescribed qualification and experience indicated are bare minimum & mere possession of the same will not entitle any candidate to be called for presentation. The application may be shortlisted on the basis as deemed appropriate by the Competent Authority.

- 5. The response submitted to this EoI and all correspondence shall be in English/Hindi and shall conform to the forms attached. Any interlineations, erasures or over writings shall be valid only if they are initialled by the authorised person signing the EoI.
- 6. At any time prior to deadline for submission of Eols, NIFT Kangra may modify the Eol document. The amended document shall be notified through print & electronic media and such amendments shall be binding on the interested Guest Faculties.
