- 3. The Tender document will be received up to 27/09/21 at 4:00PM.
- 4. The technical as well as financial bid will be opened on 28/09/2021 at 11:00 AM onwards
- 5. The bidder is requested to see all the items before quoting the price on any working day between 9.30 am to 4.30 pm.
- 6. The rate quoted should be at least more than the book value.
- 7. The highest quote (H1) on overall price will be considered.
- 8. GST 18% will be applicable over the H1 quoted rate.
- 9. The bidders should quote the price for the lot. Quotes for selected items will not be considered and liable for rejection of the tender.
- 10. Offer letter will be issued to the H1 vendor on the 28/09/2021 or on the next working day.
- 11. The selected highest (H1) quoted bidder should deposit the quoted amount to NIFT, Kangra Bank account
- 12. The scrap items will have to be removed from this office premises within 72 hours after making payment of full tender value.
- If the successful tenderer fails to remove the items with in the three days, a penalty @ Rs.500/- per day will be levied.
