National Institute of Fashion Technology, Kangra Campus invites sealed tenders from Contractor registered with HPPWD for civil construction work for NIFT Kangra Campus Himachal Pradesh with its 60 officials. **NIFT Kangra is an educational Institution of Design, Management & Technology. A statutory Body governed by NIFT Act 2006 and set up by the Ministry of Textiles Government of India.**

Scope of work: It is proposed to have services of a contractor duly registered with the HPPWD for this work. The works involves the following activities:

- Providing and fixing of parking interlocking concrete tiles 60 mm / Chamba Stone 18 mm thickness minimum / Vitrified Parking Tiles 12 mm minimum thickness as per drawing and technical specifications. Earnest Money Deposit

The tenders complete in all respects in a sealed cover and super scribed as "Tender for Interlocking tiles and rubble masonry work" which should be submitted on or before the last date 05.01.2021 (up To 2.30 PM) in the Admin Office (NIFT Kangra) along with an earnest money of Rs. 25,000 of bid amount in the form of Account Payee Demand Draft in favour of "NIFT", payable at Kangra & drawn on any of the commercial bank.
