Subject: **Reopening of Institute in phased manner and opening classes for UG – 6th Semester, 8th Semester DC and PG 2nd Semester students**

It is hereby informed that NIFT Kannur has decided to re-open the Institute in phased manner. Initially, the Institute will be opened for the UG 6th Semester, 8th Semester DC & PG 2nd Semester. All students will have to submit consent from their parents and a declaration that they will follow all COVID 19 guidelines issued by the State/Central Government and NIFT. It is advised that students from outside Kerala States may produce a Covid negative test report with a validity period of 72 hours prior to entry.

Based on above, all UG 6th Semester, 8th Semester DC and PG 2nd Semester students may plan their travel. They may reach Kannur on or before 1st March 2021 and settle down in hostels and attend classes online. Students from outside Kerala have to go for quarantine for 14 days or as per State of Kerala guidelines and each hostel student will be allotted separate rooms. The CCs will inform them the detailed plan of classes on arrival.

Classes will be on both physical and online modes (hybrid). Those who are not able to attend/prefer online mode may continue online, in case of any medical issues.

Hostel fee will be collected on pro-rata basis and first time allottee's will have to pay security deposit and other funds.

Hostel Mess will be functioning following Covid protocol and packed food will be provided to students. Students are advised to keep their own personal utensils to have extra care due to pandemic situation.

No outing will be allowed to students staying in Hostel.
