A. INTRODUCTION

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in the field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professionals and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raibareli, Shillong and Srinagar.

NIFT, Kannur Campus was established in the year 2008 with undergraduate and post graduate programmes. It is situated at DHARMASALA, MANGATTUPARAMBA on the Kannur-Taliparamba Road (NH 66) in Kannur District, Kerala.

B. NOTICE INVITING TENDER:

Director NIFT Kannur Campus invites tenders through e-procurement mode, from registered manufactures, dealers or Govt. organizations who have experience in supply and installation of Knit wear and Fashion design equipments for “Supply and Installation of machines/equipments for Knitwear & Fashion Design Departments of NIFT Kannur Campus” as per the items, specifications and quantity mentioned in the price bid/Schedule of requirement.

The Schedule of Requirements (SOR) contains five items of machines. The tenderer can opt to tender for all items or any item included in the SOR. The tenderer shall be in the field of supply and installation of Knitwear and Fashion design equipments for a period not less than three years excluding the year in which tenders are invited and should have average turnover of not less than Rupees three lakh if quoted for single item, six lakh for two items, nine lakh for three items and Rs.12 lakh if quoted for four or all the five items in the **last three years** previous to the year in which tender is invited. Interested firms should **apply online** and submit their tender and the bids along with scanned copies of all relevant certificates, documents, etc., as required, in support of their technical and financial bids – all duly signed and stamped – through the web site <https://nifttenders.eproc.in> from **23.11.2018 12.00 hours to 14.12.2018 up to 15.00 hours**. Tender documents can also be viewed on the “tenders” link of the NIFT website i.e. <https://nift.ac.in/kannur/tenders>. Application through any other mode will not be considered.

NIFT is registered with Department of Scientific and Industrial research (DSIR) and are eligible for exemption for Central Tax leviable on Scientific and Technical instruments, apparatus and equipments as per Notification No.45/2017-Central Tax (Rate) dated 14 November 2017.

For applying online, the interested Firm should first get itself registered at <https://nifttenders.eproc.in> by paying **online**:

C. INSTRUCTIONS TO BIDDERS (ITB).

1. The tenderer may inspect the site before quoting his rates and acquaint himself of the site conditions in his own interest and at his own cost. It is the responsibility of the tenderer to collect all information and data regarding the kind of machinery required by NIFT under this tender, for quoting the rate and to enter into the contract.
2. It is the responsibility of the tenderer to read all terms & conditions of this tender carefully before submitting the tender. Incomplete tender documents / or bids not responsive enough to the tender terms, is liable to be rejected.
3. Vague/incomplete details in the offer shall make it liable to be rejected as; such shortcomings in the offer shall be interpreted as incompetence and disinterest on the part of the bidder to meet tender requirements.
4. Tenderers may submit bids for all equipments given as item 1 to 5 under Schedule of Requirements/Price bid format or choose to bid for one or more items.
5. If any difference is found in the hard copy of the tender documents and that submitted online, only online bid(s) will be considered.
6. The bids shall be exactly according to the prescribed formats. Modifications/rewording of formats shall not be acceptable.
7. All documentations are required to be in English.
8. In case a company/firm wishes to authorize some other company or a firm to submit bids on its behalf, valid authorization letter should be attached.
9. Tender should be filled with neat legible and correct entries. Indistinct figures, erasures and alterations are not permitted in the tender. Please cross out any mistakes and rewrite the same and counter sign/attest by the authorized signatory. Failure to comply with the conditions may result

in rejection of the tender.

10. Incomplete tenders, amendments and additions to tender after opening the tender and tenders submitted after the last date and time prescribed for submission shall be liable to be ignored.
11. Cost involved in submitting the bids, attending the tender opening meeting, arrangements for the demonstration/presentation etc. shall be borne by the bidder.
12. The catalogue/Brochure for the Item quoted by the vendors with model and detailed specifications shall be enclosed
13. The bidder shall be free from any encumbrance and there shall not be any vigilance/ CBI /Court Case pending against the firm. The bidder shall not be black listed by any Govt. /Semi Govt. /Private Institution. A self-certificate in this regard shall be enclosed as in **Annexure -I**.
14. Having ISO certification will be an added qualification.
15. Price shall be mentioned in Indian Rupee in figures as well as in words. If any discrepancy is observed in the amount written in the figures and that in words, the amount written in words will prevail. No overwriting or use of correction fluid shall be accepted. Corrections, if any, shall be legible and signed/attested by the authorized signatory. Each bid must contain the unit price of each machine/equipment in figures as well as in words.
16. The financial bid shall include all charges (with Break up details) including applicable taxes etc., to complete the supply and installation in all respect.
17. NIFT will not accept any claim other than mentioned in financial bid.
18. The selected firm(s) has to provide after sale services for the products.
19. If any relative of the tenderer is an employee of the NIFT the name, designation and relationship of such employee shall be intimated to the Director, NIFT in writing while submitting the tender.
20. **Signing the Tender:** Each page of the tender form should be signed and stamped for the purpose of the tender offer. The individual signing the tender and the documents in connection therewith must specify whether he/she is signing as:
 - (i) A sole proprietor of the firm, or constituted attorney of such a proprietor.
 - (ii) A partner of the firm if it is partnership, in which case he/she must have the authority to sign either by virtue of the partnership agreement or power of attorney.
 - (iii) Authorized signatory of the firm, if it is a company (a letter of authority in this respect must be enclosed along with the bid).
 - (iv) A person signing the tender form or any part thereof, on behalf of another, shall be deemed to warrant that he/she has the authority to bind the other and if on inquiry it appears that the person so signing has no authority to do so, NIFT may without prejudice to other Civil and Criminal remedies, cancel the contract and hold the signatory liable for all costs and damages that may arise.

- g. Client list with minimum three references of which at least ONE shall be Government Departments/Organizations / Institutions to which similar items have been supplied, installed and successfully commissioned during the last three years commencing from 2015-16.
- h. Contact details of officials concerned in the institutions/organizations included in the client list with telephone numbers, address, email, etc. along with specifications of the equipments supplied and installed.
- i. Copy of partnership deed for partnership firm or Memorandum of Association and Articles of Association/certificate of incorporation in the case of companies or Registration certificate in respect of Societies/firms.
- j. Copy of PAN card of the firm/institution and latest Income Tax Clearance Certificate.
- k. Copy of income tax return filed by the tenderer during last 3 financial years
- l. Copy of GST Registration.

iv. **FINANCIAL BID COVER SHOULD CONTAIN scanned copy of** The Financial Bid in the stipulated format (**Annexure-VII**) only without any condition.

22. Submission of hard copy of tender forms and other documents:

- i. The tenderer after submitting the tender online should also submit hard copy of the tender form and all other documents mentioned above to “The Director, National Institute of Fashion Technology, NIFT Kannur Campus, Dharmasala, Mangattuparamba, Kannur-670562, Kerala” latest by 17.12.2018:15.00 hours. Non-submission of hard copy as directed will lead to rejection of the tender application.
- ii. Hard copy of the bids also is to be submitted in two parts viz., "Technical Bid" and "Financial Bid" in separate sealed envelopes superscribed as “Supply and Installation of machines/equipments for Knitwear& Fashion Design Departments -Technical Bid" and “Supply and Installation of machines/equipments for Knitwear& Fashion Design Departments-Financial Bid" as the case may be. Cost of Tender Form and EMD in the form of Account payee Demand draft are part of the Technical bid and should be kept in the envelope containing the Technical bid.
- iii. Put the Technical bid and financial bid in separate sealed covers. Put both the sealed covers in another large cover and send to “The Director, National Institute of Fashion

- iv. Last date for receipt of hard copy of tenders in the office of the NIFT, Kannur-670562, will be 17.12.2018:15.00 hours. NIFT shall not be responsible for any postal or other delays

23. Bid Opening:

- i. The Technical Bid will be opened at 16.00 hours on 17.12.2018 in the Office of the Director, NIFT Kannur Campus in the presence of the tenderers or their representatives who choose to attend. Tender/s received after the due date and time, by whatever means, shall not be accepted.
- ii. In the event of the date specified for bid opening being declared as closed / holiday, bid will be opened at the appointed time and location on the next working day.
- iii. Financial bid of only those bidders who are found to be technically qualified after evaluation of the Technical bids will be opened.
- iv. Date of opening the financial bid will be notified separately to the technically qualified bidders.

24. Cost of Tender Form and EMD:

- i. Tenders without EMD and incomplete in content are liable to be rejected. Micro and Small Enterprises (MSEs) registered with District Industries Centers or Khadi and Village Industries commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicraft and Handloom or any other body specified by the Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006 amended from time to time shall be exempted from EMD subject to submission of documentary proof along with tender.
 - ii. EMD of the successful Bidder (if submitted) will be discharged upon the Bidder signing the agreement pursuant to Clause 2 of the General Conditions of Contract, and furnishing the performance security, pursuant to Clause 3 there under.
- iii. EMD (if submitted) of the successful tenderer may be adjusted towards security deposit payable.
- iv. EMD of the unsuccessful Bidder's (if submitted) will be discharged / returned as promptly as possible upon the successful bidders signing the agreement pursuant to Clause 2 of the General Conditions of Contract or after the expiration of the period of bid validity prescribed in the NIT.
- v. The EMD will NOT bear any interest for the period retained by NIFT.

25. Right of acceptance:

- i. NIFT reserves the right to reject any or all the bids without assigning any reason(s) thereof. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order at the sole discretion of NIFT. NIFT is NOT bound to accept the tender quoting the lowest rate in the financial bid.
- ii. NIFT reserves the right to change the quantity/upgrade the criteria/drop any item or part thereof /change in the scope of work and the bidder shall have to supply the items at the same Unit Rate mentioned in their bid.

26. Bid Validity:

The bid shall remain valid for 90 days from the date of opening of the Financial Bid. Validity beyond 90 days from the date of opening shall be on mutual consent.

27. Bids received shall be evaluated as per the Bid Evaluation Criteria given below. NIFT will not entertain any modification subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respects as per requirement of tender document.

D. TECHNICAL QUALIFICATION AND BID EVALUATION CRITERIA:

Only those bidders who fulfil the under given conditions shall be considered as technically qualified. This is further subject to other conditions prescribed in the Annexures I to VIII. Financial bid of only those bidders who are evaluated as technically qualified only will be considered for opening.

1. The tenderer shall be a company/ Society/ firm/ OEM/ authorized dealer etc., registered under the relevant rules or Central or State Government PSU/ Central or State Government Department. Tenders from those who do not have valid registration of their institution and valid GST Registration will not be accepted. The tenderer should have valid PAN.
2. The tenderer shall have experience of not less than three years (excluding the year in which the tender is floated), in the field of supply and installation of Knitwear & Fashion design equipments or similar products. In case tenderer is a dealer, the tenderer and the OEM of the product shall be in existence for not less than three years reckoned as above. The tenderer has to furnish client list with minimum three references of which at least ONE shall be a Government Department/Organization / Institution where similar equipments had been supplied, installed and successfully commissioned by them. Such references should be complete in all respect with email address and other contact details of the personnel concerned.
3. The annual turnover of the firm in the last three years commencing from 2015-16 shall not be less than Rupees three lakh if quoted for single item, six lakh for two items, nine lakh for three items and Rs.12 lakh if quoted for four or all the five items. The turnover details shall be supported by copy of audited Balance Sheets and Profit & Loss Statements or certificate of Turnover (if accounts not finalized) issued by a Chartered Accountant.
4. The Technical bid cover should contain EMD calculated at the rate of Rs.8000 (Rupees Eight thousand only) for each equipment from Sl No. 1 to 4 of the Schedule of requirement/price bid and Rs.2000 (Rupees Two thousand only) for item at Sl. No.5 (Rs.34000 if quoted for all the five items) in the form of Account Payee DD drawn in favour of National Institute of Fashion Technology, Kannur and payable at Kannur towards EMD.
5. Technical Bid cover should contain ANNEXURE I to V of the tender document duly filled in signed and stamped and check list for submission of bid in the format attached as ANNEXURE – VI (signed and stamped).The information given in the *Annexures* shall be supported by documents wherever required.
6. The large cover should contain both ‘Technical bid’ cover and ‘Financial bid’ cover.
7. The tenderer shall accept all terms & conditions mentioned in the tender document.
8. The tenderer should provide warranty/guarantee and free service for a minimum period of one year as in **Annexure -I**.
9. The tenderer shall not be blacklisted by Central / any State Government or any Central/State PSU and no vigilance / CBI enquiry or Court Case has been registered against the tenderer.

F. GENERAL TERMS AND CONDITIONS:

1. **Forfeiture of EMD:**EMD will be forfeited to NIFT if the selected/successful bidder:
 - a. Does not accept the Purchase order/work order or backs out after acceptance
 - b. Fails to submit performance guarantee/security deposit and/or sign the formal agreement.
 - c. If the tenderer withdraws the tender after submission. Such tenderer may be disqualified from participating in any future tender of the Institute.
