- 1. - 1.Actual delivery (and Installation & Commissioning (if covered in scope of supply)) is to be done at following address National Institute of Fashion Technology NIFT, Campus, Dharmashala Opp.Govt Engineering College Mangattuparamba, Kannur, Kerala Pin 670562.
- 2.Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 3.Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
- 4. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 5.The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. - 14.
