2. **Jurisdiction:** In case of any dispute the Jurisdiction of Court will be Kannur, Kerala. In case of disputes raised by the Service Provider, a representation will be made only by the supplier or the authorized representative of the supplier and the decision of the Director NIFT Kannur will be binding on the supplier.
3. **Interpretation of Clauses:** In case of ambiguity in the interpretation of any of the clauses in the tender/contract document, the Tendering authority's interpretation of the clause shall be final and binding on the Agency.
4. All the documents attached in the buyer-uploaded ATC document shall be part of the tender.
5. Bidder can also submit the EMD and PBG in the form of Insurance Surety Bonds as per GFR.
