SCOPE OF WORK

- a) To keep all the systems in good working condition:
 - i) Maintenance of all Hardware/Software (Computer/Laptop, Printer & Scanner, etc.)
 - ii) Installation & maintenance of all Software
 - iii) Anti-Virus loading, regular updating and virus cleaning
 - iv) Shifting and reinstallation of PCs/Printers/Scanners, etc. as and when required.
- b) The AMC includes upkeep of systems including installation of Operating Systems (OS) & all the software (Adobe CC Suit, Corel, Auto CAD, 3D Studio Max., Antivirus, etc.). Software will be provided by NIFT.

c) SPARE PARTS REPLACEMENT

Faulty parts that need replacement are to be replaced with the same specification and of same make; if the spare parts of same specification and make is not available the same will be replaced with spare/parts of higher specifications/ configuration and/or of make/brand agreed by NIFT. The replaced spare parts should be new and at par or higher with the faulty parts.

For Printer all spare part including roller and Talon are covered under comprehensive AMC

d) **UP-TIME**

The service provider should attend to any call within 2 hrs. from the time of logging of the call and fault should be rectified within 4 to 5 hours. If the fault is not rectified within 12 hours from the time of registering the complaint, the contractor should provide stand-by system with the same or higher configuration.

e) Preventive maintenance of each system should be done at least once in each month.

TERMS AND CONDITIONS

- 1. Only on-line bids will be considered. Please read the terms & conditions carefully before online submission/filling up the document. Incomplete tender documents will be summarily rejected.
- 2. Conditional and/or offline tender will not be accepted and/or the condition(s) may not be considered.
- 3. The Contract shall be initially for one year and may be extended/renewed for further periods subject to satisfactory service and/or as per requirement of NIFT, Kolkata.
- 4. The agency/tenderer should have atleast three years of relevant experience in executing/rendering such services. The agency should have at least 3 work order, with AMC value of minimum 3 lakhs.

- 5. The contract for Comprehensive AMC of IT Infrastructure shall be commercial contract and between NIFT & the successful tenderer. There shall be no employer-employee relationship between NIFT and the Tenderer or the staff/personnel deputed by the said contractor.
- 6. Hard copy of tender(s) submitted beyond the scheduled last date & time due to whatever reason including postal delays and without the required fees, Annexure(s) & documents will not be considered.
- 7. All tenderers are required to submit **Earnest Money Deposit (EMD) of Rs.20,000/** (refundable) in the form of Demand Draft (should be drawn beyond the date of notification of this NIT) in favour of NIFT Kolkata payable at Kolkata. No interest shall be paid on the said EMD and will be returned after finalization of the tender; however, the EMD of the successful bidder will remain with NIFT and will be forfeited in the following events:
 - a. If information declared/document submitted found false/fake/forged
 - b. If the selected/successful bidder does not accept the W.O., or, unable to provide services
 - c. If the bidder withdraws his bid/quote

However, those who have valid NSIC registration certificate, Tender Cost & EMD may not be required.

- 8. The successful tenderer shall be required to deposit 10% of work order value (AMC cost) as Security Money within 15 days of receiving of Work Order. No interest shall be paid on such security deposit, which shall remain with the Institute during the entire period of the contract and it shall be released after two months from the date of expiry of the contract after deducting dues, recovery, etc., if any and as applicable. However if the contract is terminated due to any default of the contractor, the said security deposit will be forfeited.
- 9. The minimum annual turnover of the tenderer for the last two years should not be less than **Rs.100 Lakhs** per year which should be substantiated by valid document(s), viz. PL/IT Returns/Audit report, etc..
- 10. Even after qualifying in the technical bid, the financial bid may be rejected if not found in order. Merely qualifying in the technical bid does not ensure acceptance of the financial bid.
- 11. In case of L-I is more than one, the selection criteria [viz. the past performance, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such a situation, will be final in all respect and will be binding to all the tenderers.
- 12. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of clients, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
- 13. The AMC is of Comprehensive type, i.e. Inclusive of all spares/parts etc. One/more efficient service engineer(s) should be stationed to carry out the assignment smoothly and no extra payment will be made for the same. Tenderer should quote accordingly.

- 14. All statutory obligations under various laws from time to time will have to be met by the contractor for which no extra payment shall be made to him at any time during the contract period. NIFT will no way be responsible for any default with regard to any statutory obligation.
- 15. The quotes should be valid for all the tenders at least 3 months from the date of opening of the tender; however, rates quoted by successful tenderer shall be valid for the entire period of contract. Prevailing statutory rates as revised by the Govt. from time to time will be considered. Also applicable rates as may be fixed by the Govt. from time to time will be considered.
- 16. The Successful Bidder should depute competent service engineer(s) for trouble shooting and maintenance as and when required. In emergency/urgent/unavoidable circumstances the contractor may be required to provide the service on Saturday/Sunday/holidays also, which will be communicated accordingly.
- 17. Payment Terms: No payment shall be made in advance. Payment will be made quarterly in arrear basis against bill in triplicate and based on satisfactory certification by the concerned NIFT official(s), Kolkata. Penalty may be imposed on the bill amount due to non-satisfactory service. Generally the penalty amount will be 5-10% of the bill amount; however, the same may vary based on the level of performance which may be decided by the NIFT authority and decision of NIFT in this regard will be final & binding on the contractor.
- 18. As per the NIFT policy, payments and receipts to Government and Semi Government Agencies would be rounded off to the nearer higher rupee and in other cases the rounding off will be to nearest i.e., paisa 50 or above will be rounded off to the near higher rupee and paisa less than 50 will be ignored.
- 19. The number of items/systems covered under this AMC as mentioned in Annexure "IV" for which AMC is being done may vary (increased/decreased) and payment will be made on actual based on the quoted rate.
- 20. If any call is not attended within 4 hrs. of booking of call made or the agency is unable to resolve any call, NIFT reserves the right to get it rectified from any other agency/source and cost of the same will be deducted from the bill/security deposit and/or the agency will pay for the same.
- 21. In case of any damage or loss to the Institute's property or material caused directly or indirectly by the personnel, the agency shall be held fully responsible, and the Institute shall be entitled to recover appropriate amount with/without penalty from the amount payable to the Agency. The amount of loss or damage as determined by NIFT shall be final and binding on the Agency.
- 22. The Contractor shall not engage any Sub-Agent or Sub-Contractor whatsoever for the said AMC.
- 23. NIFT will not provide any mode of transport in respect of men or material required by the contractor for executing the AMC.

- 24. The Contractor shall abide by the Rules and Regulations of the NIFT, as may be enforced from time to time. The Contractor will have to work in close co-operation with others at the site.
- 25. The contract may be withdrawn by either side due to any reason by giving a minimum of 30 days' notice. The agreement with NIFT, in such cases, will be treated as cancelled before its expiry. However, NIFT reserves the right to terminate the contract at any point of time at its sole discretion due to non-satisfactory service or violation of T&Cs or due to any applicable reason and NIFT's decision in this regard shall be final and binding on the contractor.
- 26. The Bidder shall quote the rates in figures as well as words. If there in any mismatch, either the lower amount will be considered or the quotation may not be accepted as may be decided by NIFT authority and decision of NIFT in this regard shall be final & binding.
- 27. An agreement on Non-judicial Stamp paper containing all the terms and conditions of the service is to be made by the successful tenderer with NIFT within one month from the date of issuing of work order and the same shall be notarised by the contractor at his own cost.
- 28. It is strongly recommended that the tenderer should inspect the site any time during working hours on any working day with prior appointment (Tel.033-23357546) before submission of bid; no extra amount shall be payable for non-awareness of the items or the site conditions and constraints, if any.
- 29. Any query/clarification with respect to the tender (T&Cs, etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted (033-23357546) in this regard in between 9.00 am to 5.30 pm on any working day. However, NIFT will not entertain or clarify any such query during post bid.
- 30. All disputes are subject to Kolkata Jurisdiction only.
