National Institute of Fashion Technology (NIFT was set up by the Ministry of Textiles Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in Management to address the specialized needs of professional and students in the field on fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinanagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Rae Bareli, Shillong and Srinagar.

NOTICE INVITING TENDER

NIFT, Kolkata invites **online** tender under <u>two bid systems</u> for "Comprehensive AMC of UPS System" from eligible reputed Firms/Agencies having at least 03 (three) years work experience in executing similar kind of services/jobs in Central/State Govt. Department/PSUs/MNCs Reputed Academic Institutes/Organizations.

SUBMISSION OF BID AND AVAILABILITY OF TENDER DOCUMENT

i. Complete set of Bidding Document in English may be downloaded at free of cost from CPP Portal (URL: https://eprocure.gov.in/eprocure/app) and from NIFT's website URL:https://nift.ac.in/kolkata.

Corrigendum/addendum, if any, shall be published only on the aforesaid website and separate communication in this regard will not be sent for the same to any individual.

iii. Bids shall be submitted through online only. Manual / physical bids will not be accepted.

A) Scope of Work

To maintain and upkeep the UPS Systems installed in NIFT, Kolkata.

- 1. Preventive maintenance should be done at least once in each month. In this connection a logbook should be maintain by the contractor and should get it signed from Computer engineer/concerned NIFT official after rendering each preventive maintenance.
- 2. Penalty of 5%-10% may be imposed on the bill amount due to unsatisfactory service. In case of breakdown of the UPS system, the vendor should attend any such call within 1-2 hours. Any fault should be rectified within 4 to 5 hours. If the fault is not rectified within 08 hours from the time of registering the complaint, the contractor should provide a stand-by at your own cost of UPS system with the same or higher configuration.
- 3. Service should be provided during NIFT's working hours on all working days and even on holidays in case of emergency.

Terms & Conditions:

- 1. Only on-line bids will be considered. Please read the terms & conditions carefully before online submission/filling up the document. Incomplete tender documents will be summarily rejected.
- 2. Conditional or offline tender will not be accepted or the condition(s) may not be considered.
- 3. The Contract shall be initially for one year and may be extended/renewed for further periods subject to satisfactory service.
- 4. The agency/tenderer should have <u>at least Three years</u> of relevant experience in executing/rendering such services.
- 5. The contract for Comprehensive AMC of UPS System shall be commercial contract and between NIFT & the successful tenderer. There shall be no employer-employee relationship between NIFT and the Tenderer or the staff/personnel deputed by the said contractor.
- 6. Tender(s) submitted beyond the scheduled last date & time due to whatever reason including postal delays and without the required fees, Annexure(s) & documents will not be considered.

- 7. The successful tenderer shall be required to deposit **Security Money of 10%** of the AMC value within 15 days of receiving of Work Order. No interest shall be paid on such security deposit, which shall remain with the Institute during the entire period of the contract and it shall be released after two months from the date of expiry of the contract after deducting dues, recovery, etc., if any and as applicable. However if the contract is terminated due to any default of the contractor, the said security deposit will be forfeited.
- 8. The bidder should have minimum of <u>3 (three) years experience</u> in the relevant field. The average minimum annual turnover of the tenderer for past 02 (two) years should not be less than Rs.5.00 Lakh (Rupees Five Lakh Only) which should be substantiated by Audit report/ITR.
- 9. All the DD (s) are to be submitted along with the Technical Bid only. All bidders should mention their company name and tender/NIT no. at the back of the DD(s).
- 10. The AMC is of Comprehensive type, i.e. inclusive of all spares/parts etc.. And The Faulty parts that need replacement are to be replaced with the same specification and of same make; if the spare parts of same specification and make is not available the same may be replaced with spare/parts of higher specifications/ configuration and/or of make/brand agreed by NIFT. The replaced spare parts should be new and at par or higher with the faulty parts.
- 11. The quotes should be valid in the case of all the tenderer for at least 3 months from the date of opening of the tender and if tenderer withdraws during the period, the EMD shall be forfeited. In case of the successful tenderer, rates quoted shall be valid for the entire period of contract.
- 12. Initially the contract shall be for one year only and the contract may be renewed or extended for further periods on mutually agreed T&Cs subject to satisfactory services of the agency.
- 13. If the service provider is unable to attend call or unable to provide service within the stipulated time period, NIFT reserves the right to get the work done from outside party and in such cases the expenses/lost for the same will be deducted from the security deposit and/or from the bill amount payable to the service provider by NIFT and/or the contractor shall pay for the same.
- 14. NIFT shall in no way be responsible for default with regard to statutory obligation, if any, related to the manpower deputed by the successful agency/firm to render the said service. It will be the sole responsibility of the successful bidder. All statutory obligations under various laws from time to time will have to be met by the contractor for which no extra payment shall be made to him at any time during the contract period.
- 15. The Tenderer is required to quote as per "Annexure IV" separately.
- 16. The number of items/systems mentioned in **Annexure "IV"** for which AMC is being done may be increased/decreased and payment will be made on actual based on the quoted rate.
- 17. No payment shall be made in advance. Payment will be made quarterly in arrear basis against bill in triplicate and based on satisfactory service duly certified by the concerned NIFT official(s), Kolkata.
- 18. Penalty: Penalty may be imposed on the bill amount due to un-satisfactory service and during breakdown service for UPS Systems should be attended to any call within 1-2 hours. From the time of reporting/ logging of call by the NIFT official(s) and any fault should be rectified within 4 to 5 hours. If the fault is not rectified within 08 hours from the time of registering the complaint, the contractor should provide a stand-by UPS System at their own cost with the same or higher configuration. Generally the penalty will be 5-10% of the bill amount; however, the same may vary based on the level of performance which may be decided by the NIFT authority and decision of NIFT in this regard will be final & binding on the contractor.

- 19. If the contractor is responsible for any loss or damage to Institute's moveable or immovable property due to the conduct of the contractor's staff, the same shall be made good by the contractor at his own cost. If it is found that the conduct or efficiency of any person deployed by the contractor is unsatisfactory, the contractor shall replace him immediately and depute a new person under intimation to NIFT.
- 20. NIFT will not provide any mode of transport in respect of manpower or any items/materials required by the contractor for executing the AMC.
- 21. Lowest bid may not be the only criteria for selection; preference shall be given to the other factors, viz. previous relevant experience with other organization(s), turnover, quality of service, reputation, etc. and successful tenderer will be selected accordingly. Decision of NIFT Authority in this regard shall be final and binding on all the bidders.
- 22. In case of L-I is more than one, the selection criteria [viz. the past performance, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such a situation, will be final in all respect and will be binding on all the tenderers.
- 23. The Contractor shall not engage any sub-agent or sub-contractor whatsoever for running the said AMC Service.
- 24. The Contractor shall abide by the Rules and Regulations of the NIFT, as may be enforced from time to time. The Contractor will have to work in close co-operation with others at the site.
- 25. It is strongly recommended that the tenderer should inspect the site any time during working hours on any working day with prior appointment (033-23357546) before submission of bid; no extra shall be payable for lack of knowledge of the site conditions/items and constraints, if any.
- 26. The contract may be withdrawn by either side due to any reason by giving a minimum of 30 days' notice. The agreement with NIFT, in such cases, will be treated as cancelled before its expiry. However, NIFT reserves the right to terminate the contract at any point of time at its sole discretion due to non-satisfactory service or violation of T&Cs or due to any applicable reason and NIFT's decision in this regard shall be final and binding on the contractor.
- 27. The Bidder shall quote the rates in figures as well as in words. If there is any mismatch, either the lower amount will be considered or the quotation may not be accepted or as may be decided by NIFT authority and decision of NIFT in this regard shall be final & binding.
- 28. An agreement on Non-judicial Stamp paper containing all the terms and conditions of the service is to be made by the successful tenderer with NIFT from the date of issuing of work order and the same shall be notarised by the contractor at his own cost.
- 29. Any query/clarification with respect to the tender (T&Cs, etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted in this regard in between 9.00 am to 5.30 pm on any working day with prior appointment (033-23357546). However, NIFT will not entertain or clarify any such query during post bid.
- 30. All disputes are subject to Kolkata Jurisdiction only.

NIFT reserves the right to accept or reject any or all the tenders in part or whole or may cancel the tender at any stage of the tendering process at its sole discretion without assigning any reason whatsoever and decision of NIFT in this regard shall be final and binding. No further correspondence in this regard will be entertained.
