- 2. - 3. Bidders are required to submit **Earnest Money Deposit of Rs. 2,000/-** (Rupees two thousand only) only through Demand Draft drawn after the date of NIT in favour of SPGS, Bhagaiya along-with the Technical Bid. The Earnest Money will be refunded within 60 days of opening of tenders. The bids without EMD shall be rejected. This Earnest Money Deposit (EMD) will not bear any interest. **The EMD will be forfeited in following cases:**

•If selected bidder does not supply the materials.

- 4. Tender received without EMD or if the EMD amount is less than the amount specified shall not be considered.

- 14. If the successful bidder fails to supply the ordered quantity within the stipulated time frame, the Institute will have the right to purchase the ordered quantity (which the supplier could not supply) from any other alternate sources and the contract will be liable to be terminated and the EMD/ Security deposited will be liable to be forfeited.
- 15. Tender of branded/ reputed make shall only be considered. Assembled or locally manufactured items shall not be entertained.
- 16. The schedule issued with the form of tender listing the details of item to be supplied must not be altered by the tenderer. Any modifications/ alterations of the schedule considered necessary by the tenderer, should be in a separate letter accompanying the tender.
- 17. No paper shall be detached from the tender form.
- 18. The Original Equipment Manufacturers (OEM) must certify against machine(s) that the machine concerned has been manufactured by them. A certificate to this effect must be enclosed.
- 19. The tender shall be submitted in two separate sealed envelopes one for the Technical Bid (as per Annexure-I) and the other for Financial Bid (as per Annexure-II) which should be clearly superscribed on the envelops. The 2 covers duly sealed (i.e. Technical Bid & Financial Bid) should thereafter be kept in a third bigger cover & sealed. - 20. Tenderer submitting single quotation or combining "Technical" & "Financial" bid is liable to be rejected.

- 26. The full & final payment shall be made after delivery and successful installation and satisfactory report submitted by SPGS Official and submission of bill. VAT/CST/ TDS/ etc., if any, will be deducted during payment.
- 27. The successful bidder shall deposit the **Security Deposit of 5% of the order value** through DD in favour of SPGS Deoghar **after receipt of Purchase Order**. No interest will be paid on this deposit which will be refunded after two months on completion of warranty period of the tools/machineries/ equipments and after adjusting dues, if any.
- 28. As per SPGS policy, would be rounded off to the next higher rupee and in other cases the rounding off will be to nearest i.e. paisa 50 or above will be rounded off to the next higher rupee and paisa less than 50 will be ignored.
- 29. The supplier shall ensure that he himself or his authorized representative is available for proper handing over the supplies/consignments at SPGS Centre.
- 30. In case L-1 is more than one, then the Technical qualification of the Tenderer will be the criteria and the decision of SPGS will be final and binding.
- 31. The specification of tools and machineries has been provided at Annexure 'A'.
- 32. Delivery is required to be completed within 30 days from the date of acceptance of supply order.

- 35. The vendor should have the qualified engineers/ staff to attend to After Sales Service at SPGS Bhagaiya campus Centre where the machines are to be supplied and installed.
- 36. The machines/ equipments supplied and installed should be New and Unused.
- 37. The pre-inspection /post inspection of the machines may be undertaken by SPGS Deoghar and the machines shall be accepted only after the machines are certified 'OK' by the Inspecting Engineer/Body.
- 38. For the said tools/machineries to be supplied and installed, the Insurance Coverage shall be at the cost of the vendor & his responsibility shall be up to 'FOR Destination' i.e. SPGS Centre.
- 39. The installation of the equipments/ machineries shall be the responsibility of the vendor and it should be certified as in working condition by the consignee after the installation.
- 40. A penalty as decided by the Competent Authority of SPGS for any defective machines supplied shall be payable & the same shall be deducted from the bill or the Security Deposit, as the case may be, for any such defect in the equipments/machineries developed/noticed later on during the currency of warranty and not set right or for any non compliance of any terms & conditions other than time clause by the supplier.
- 41. SPGS has sole discretion to either amend or cancel any or all the tender items without assigning any reason whatsoever.
