NIFT Kolkata invites **online** tender under two bid systems for “Arrangement of Stage, Ramp, Light & Sound and Stalls etc. for Fashion Spectrum-2020” from the eligible reputed Firms/ Agencies.

Applications to this tender will be accepted only in the online mode through the website <https://nifttenders.eproc.in>. No other mode of application will be considered & accepted.

Terms and Conditions

1. Only online bids will be considered.

In addition to on-line, the hardcopy of the Technical Bid (Annexure-I, II & III only) along with necessary fees through DD, and relevant documents should be submitted within the specified date & time at the said address. Annexure-IV (Financial Bid) to be submitted online only.

2. Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.

3. Conditional or offline tender will not be accepted or the condition(s) may not be considered.
4. Bidders are required to submit **Earnest Money Deposit (EMD) of Rs.5,000/-** (Rupees Five Thousand only) through Demand Draft (drawn after the date of NIT) in favour of NIFT, Kolkata along-with the Technical Bid. The Earnest Money will be refunded after finalization of tender. This EMD will not bear any interest. The EMD will be forfeited in following cases:
 - If information declared/document submitted found false/fake/forged
 - If selected bidder does not execute the work [either fully or partially]
 - If selected bidder supplies sub-standard materials
5. Tender received without EMD or if the EMD amount is less than the amount specified shall not be considered.
6. EMD of successful bidder will be retained and will be returned only on receipt of performance security. No interest shall accrue on this deposit.
7. The Financial Bids of technically qualified bidder only will be opened.
8. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
9. The tenderer must have at least 3 years of experience in the relevant field and execution of similar kind of works in other reputed organisations.
10. In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers.
11. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; due weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
12. All Taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive. Statutory rates are subject to change and will be considered as may be fixed by the Govt.
13. The annual turnover of the tenderer during the last two years should not be less than Rs.10.00 Lakhs per year (FY 2016-17 & 2017-18).
14. The successful bidder needs to deposit Security Money of 5% of the Work Order value through Demand Draft favouring NIFT Kolkata which will be refunded/ returned, without any interest, after one year from the date of completion of the work with deduction, if any and as applicable.
15. The venue (including stalls) complete in all respect (stage, ramp, light & sound, etc.) should be ready well in advance before the scheduled date of the programme on both the days failing which penalty will be imposed on the bill amount as will be decided by NIFT Authority and decision of NIFT in this regard shall be final and binding. However, delay due to any applicable/ unforeseen reason, viz. natural calamity and other force majeure clauses may be considered as per the decision of the NIFT Authority.
16. The DD(s) [EMD] is to be submitted along with the Technical Bid only and NOT with the Financial Bid.
17. The quotes should be valid for at least 3 months from the date of opening of the tender however, for the successful bidder the rates will be valid till completion of the job.
18. No payment shall be made in advance. The payment shall be made after completion of the work in all respect and on the basis of certification by the concerned NIFT Official(s). TDS, etc., if any and as applicable, will be deducted during payment.
19. The quantity of items of work may vary and payment will be made based on actual.

23. The schedule issued with the form of tender listing the details of item to be executed must not be altered by the tenderer. Any modifications/ alterations of the schedule considered necessary by the tenderer, should be in a separate letter accompanying the tender.
24. The tender is liable to be rejected if complete information is not given or if the particulars and data (if any) asked for in the Schedule of the tender are not filled in correctly.
25. Late submission of tender will not be considered.

29. *It is strongly recommended that the tenderer should inspect the site any time during working hours on any working day with prior appointment [contact no.033-2335-7546]; no extra amount/ charges shall be payable for lack of knowledge of the site conditions and constraints, if any.*
30. Tenderer must sign along with company seal on all the pages submitted with the tender document.
31. All disputes are subject to Kolkata Jurisdiction only.

NIFT reserves the right to accept or reject any or all the tenders either fully or partly or may cancel the tender without assigning any reason and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the commercial bid and decision of NIFT in this regard shall be final & binding on all the tenderers.
