#### **INTRODUCTION**

National Institute of Fashion Technology (NIFT was set up by the Ministry of Textiles Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in Management to address the specialized needs of professional and students in the field on fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinanagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Rae Bareli, Shillong, Srinagar and Panchkula.

#### SCOPE OF WORK:

- i) Comprehensive Annual Maintenance Contract for 5555 GPH capacity Water Treatment Plant installed at NIFT Kolkata.
- ii) Dozing material, liquid chlorine to be supplied @ 50 ltr. Per month.
- iii) Thorough servicing and maintenance of Cylindrical vertical type Iron Removal Filtration Plant, which is capable of treating water at the rate of 5555 GPH and consisting of Oxidation chamber, Iron removal filter along with connected pipelines, fittings, valves and filter media and other ingredients i.e filter materials of required quantity, sand, gravels etc.
- iv) Back washing of the filter/plant as a whole of the above plant:— at least 3 nos. of backwashing service per week.
- v) Thorough servicing and maintenance of two (2) nos. 7.5 HP motor of capacity 25 cum per hour against a head of 2–3kg/cm<sup>2</sup>. Make: Kirloskar Pump Motor set for raw water feed pump to the filtration unit.
- vi) Thorough servicing & maintenance of 3 HP rated compressor unit.
- vii) Associated Electrical panel with starter etc work of the plant which includes new control panel of pump-motor etc. complete
- viii) Necessary laboratory test certificate (from Govt./Govt. undertaking/Govt. approved oganisation) for chemical test report of water which includes Ph value test, Iron content & Turbidity test.
- ix) Break down service to be attended as and when required. preferably within 4-6 hrs. within 24 hrs. depending on the type of break down. If not attended and fault is rectified by NIFT authority, suitable penalty would be imposed as per norms.
- x) Thorough servicing and maintenance of dozing pump with associated pipeline and valve etc., Further if necessary, replacement of the same must be done.

#### Terms & Conditions:

- 1. Only on-line bids will be considered. Please read the terms & conditions carefully before online submission/filling up the document. Incomplete tender documents will be summarily rejected.
- 2. Conditional or offline tender will not be accepted or the condition(s) may not be considered.
- 3. The Contract shall be initially for one year and may be extended/renewed for further periods subject to satisfactory service.
- 4. The agency/tenderer should have <u>at least Three years</u> of relevant experience in executing/rendering such services.
- 5. The contract for Comprehensive AMC for 5555 GPH capacity Water Treatment Plant shall be commercial contract and between NIFT & the successful tenderer. There shall be no

- employer-employee relationship between NIFT and the Tenderer or the staff/personnel deputed by the said contractor.
- 6. Tender(s) submitted beyond the scheduled last date & time due to whatever reason including postal delays and without the required fees, Annexure(s) & documents will not be considered.
- 7. The successful bidder needs to deposit **3%** (Three Percent) of total contract Value as **Security Deposit** through Demand Draft favouring NIFT Kolkata within 2 weeks from the date of receiving of Work Order. No interest shall be paid on such security deposit, which shall remain with the Institute during the period of the contract and it shall be released after two months from the date of expiry of the contract after deducting dues, recovery, etc., if any and as applicable. However if the contract is terminated due to any default of the contractor, the said security deposit will be forfeited.
- 8. The bidder should have minimum of <u>3 (three) years experience</u> in the relevant field. The average minimum annual turnover of the tenderer for past 02 (two) years should not be less than Rs.1.00 Lakh which should be substantiated by Audit report/ITR.
- 9. All the DD (s) are to be submitted along with the Technical Bid only. All bidders should mention their company name and tender/NIT no. at the back of the DD(s).
- 10. The quote/rates should be valid at least 3 months from the date of opening of the tender; however, in case of the successful tenderer the quote/rate shall be valid for the entire period of contract. Prevailing statutory rates (GST, etc.) as revised by the Govt. from time to time will be considered.
- 11. In case of failure to resolve any problem or unable to render service/support within stipulate time, NIFT reserves the right to get the work done from any other source(s) and expenditure to this effect will be borne by the dddagency/service provider, either the amount will be deducted from the Bill amount and/or from the security deposit and/or the agency/contractor will pay the same.
- 12. Dispute, if any, arising out of the manpower services contract shall be settled by mutual discussion and the decision of NIFT will be final and binding in this matter.
- 13. Non-compliance of any terms and conditions enumerated in the contract shall be treated as breach of contract.
- 14. **Payment Terms:** No payment shall be made in advance. Payment will be made quarterly in arrear basis against bill in triplicate and based on satisfactory certification by the concerned NIFT official(s), Kolkata. Penalty may be imposed on the bill amount due to non-satisfactory service. Generally the penalty amount will be 5-10% of the bill amount; however, the same may vary based on the level of performance which may be decided by the NIFT authority and decision of NIFT in this regard will be final & binding on the contractor.
- 15. In the event of non-satisfactory service or any default, payment may be deducted as penalty as deemed fit which will be decided by the NIFT authority and decision of NIFT in this regard shall be final & binding on the agency/service provider.
- 16. In case of any lack of responsibility or any failure at the vendor end during any urgent/emergency/normal break down call/fault condition NIFT will be forced to engage

outsider agency to rectify the same for which the actual payment made to other agency will be deducted from the bill of the AMC vendor.

- 17. Even after qualifying in the technical bid, the financial bid may be rejected if found not in order. Merely qualifying in the technical bid does not ensure acceptance of the financial bid.
- 18. In case of L-1 is more than one, the selection criteria [viz. the past performance, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such a situation, will be final in all respect and will be binding on all the tenderers.
- 19. NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
- 20. The Tenderer shall abide by the Rules and Regulations of NIFT, as may be enforced from time to time. The successful agency will have to work in close co-operation with others at the site.
- 21. NIFT shall in no way be responsible for default with regard to statutory obligation, if any, related to the manpower deputed by the successful agency/firm to render the said service. It will be the sole responsibility of the successful bidder. Deputing Child Labour to render the said service is strictly prohibited.
- 22. The personnel to be deputed to render the said service must bear good moral character with decent personality, well disciplined and sincere. If, at any time, any of the personnel are found to be guilty of misconduct in any manner, the tenderer shall replace that person forthwith.
- 23. As per the NIFT policy, payments and receipts to Government and Semi Government Agencies would be rounded off to the nearer higher rupee and in other cases the rounding off will be to nearest i.e., paisa 50 or above will be rounded off to the near higher rupee and paisa less than 50 will be ignored.
- 24. The successful tenderer shall be solely responsible for injuries and accidents, if any due to executing the said Service to persons deputed by him for the said service at NIFT Kolkata.
- 25.In the event of injury, illness or mishap to any personnel/manpower deputed by the successful bidder to render the said service, NIFT, Kolkata will not be liable to pay any compensation.
- 26. The Tenerer will indemnify NIFT in case of any damage or liability, which may arise on account of action of any reason by the successful tenderer.
- 27. The Tenderer shall not engage any Sub-Agent or Sub-Contractor whatsoever for rendering Comprehensive AMC for 5555 GPH capacity Water Treatment Plant at NIFT, Kolkata.
- 28. It is preferred that the tenderer should have an operating office in West Bengal.

- 29. NIFT will not provide any mode of transport in respect of manpower or any items/materials required for the service.
- 30. NIFT reserves the right to terminate the contract at any point of time at its sole discretion due to non-satisfactory service or violation of Terms & Conditions or due to any applicable reason and NIFT's decision in this regard shall be final and binding.
- 31. The Bidder shall quote the rates in figures as well as words. If there in any mismatch, either the lower amount will be considered or the quotation may not be accepted as may be decided by NIFT authority and decision of NIFT in this regard shall be final & binding.
- 32. An agreement on Non-judicial Stamp paper containing all the terms and conditions of the service is to be made by the successful tenderer with NIFT within one month from the date of issuing of work order and the same shall be notarised by the contractor at his own cost.
- 33.It is strongly recommended that the tenderer should inspect the site any time during working hours on any working day with prior appointment (Tel. 03323357546) before submission of bid; no extra shall be payable for lack of knowledge of the site conditions and constraints, if any.
- 34. Any query/clarification with respect to the tender (T&Cs, etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted in this regard in between 10:00 am to 5:00 pm on any working day with prior appointment (033-23357546). However, NIFT will not entertain or clarify any such query during post bid.
- 35. All disputes are subject to Kolkata Jurisdiction only.

NIFT reserves the right to accept or reject any or all the tenders in part or whole or may cancel the tender at its sole discretion without assigning any reason whatsoever and decision of NIFT in this regard shall be final and binding on all the tenderers. No further correspondence in this regard will be entertained.
