NIFT, Kolkata invites **online** tender under two bid systems for "Construction of Two storied store room and allied works at NIFT campus Kolkata" from eligible reputed Firms/Agencies having at least 03 (three) years work experience in executing similar kind of services/jobs in Central/State Govt. Department/PSUs/MNCs Reputed Academic Institutes/Organizations.

SUBMISSION OF BID AND AVAILABILITY OF TENDER DOCUMENT

A) Scope of works

- i. Dimension of two storied store room: 7m x 5m x6m.
- ii. Supply, fitting & fixing of steel work in built up tubular (Square, Rectangular, Circular etc.) section for truss structure.
- iii. Supply, fitting & fixing of Zn-Al alloy coated (followed by colour coated) 0.45 mm thick steel sheet work for truss covering materials.
- iv. Supply & fixing of MS door with door frame as per required dimension.
- v. Brick work with common burnt clay F.P.S. (non-modular) bricks of class designation 7.5 in Cement mortar 1:4 (1 cement: 4 coarse sand).
- vi. Providing and laying in position cement concrete of 1:2:4 (M15) grade concrete for base of truss structure.
- vii. Cement concrete flooring of 1:2:4 (M15) grade concrete with net cement for flooring purpose.
- viii. Painting with synthetic enamel and finishing walls with Acrylic Smooth exterior paint of approved brand and manufacture for truss painting and masonry painting etc..

Terms & Conditions:

- 1. Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.
- 2. Conditional or offline tender will not be accepted or the condition(s) may not be considered.
- 3. The Financial Bids of technically qualified bidder only will be opened.
- 4. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
- 5. The tenderer must have at least 3 years of experience in the relevant field and execution of similar kind of works in the Govt., PSU, reputed MNCs/ organisations.

- 6. 'Credential' issued by the officer not below the rank of Exe. Engineer of the deptt./ sector will be accepted.
- 7. In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers.
- 8. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
- 9. All Taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive. Statutory rates are subject to change and will be considered as may fixed by the Govt.
- 10. Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least Rs.20 lakh.
- 11. Experience criteria: Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - a. Three similar completed works costing each not less than the amount equal to Rs.2.40 lakh.

or

b. Two similar completed works costing each not less than the amount equal to Rs.4.00 lakh.

or

- c. One similar completed work costing not less than the amount equal to Rs.5.60 lakh.
- 12. Definition of "similar work" should be clearly defined.
- 13. The successful bidder needs to deposit <u>Security Money of 10%</u> of the Work Order value through Demand Draft favoring NIFT Kolkata which will be refunded/ returned, without any interest, after one year from the date of completion of the work with deduction, if any and as applicable.
- 14. The works should be completed within 06 weeks from the date of receiving of Work Order failing which a penalty @0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order Value. However, delay due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site etc., may/ may not be considered as may be decided by NIFT Authority.
- 15. All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligation, if any.
- 16. The quotes should be valid for at least 3 months from the date of opening of the tender however, for the successful bidder the rates will be valid till completion of the job.
- 17. No payment shall be made in advance. The payment shall be made after commissioning of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable, will be deducted during payment.
- 18. The quantity of items of work may vary and payment will be made based on actual.
- 19. NIFT shall not provide any mode of transport in respect of men or material required by the contractor for execution of the work.
- 20. Any query/ clarification with respect to the tender (T&Cs, specification(s), etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted in this regard in between 10 am to 5 pm on any working day (033-23357546). NIFT will not entertain or clarify any such query during post bid.



- 21. Works shall be executed at NIFT Campus, Block-LA, Plot-3B, Sector III, Salt Lake City, Kolkata 700106 by the successful bidder.
- 22. The schedule issued with the form of tender listing the details of item to be executed must not be altered by the tenderer. Any modifications/ alterations of the schedule considered necessary by the tenderer should be in a separate letter accompanying the tender.
