7. In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. 10. Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least Rs.12.50 lakh.
11. Experience criteria: Experience of having successfully completed similar works during last 3 years ending last day of month previous to the one in which applications are invited should be either of the following:-
 - a. *Three similar completed works costing not less than the amount equal to Rs.35 lakh.*
 - or*
 - b. *Two similar completed works costing not less than the amount equal to Rs.25 lakh.*

 - c. *One similar completed work costing not less than the amount equal to Rs. 10 lakh.*
12. Definition of “similar work” should be clearly defined.
13. The successful bidder needs to deposit Security Money of 10% of the Work Order value through Demand Draft favoring NIFT Kolkata which will be refunded/ returned, without any interest, after one year from the date of completion of the work with deduction, if any and as applicable.
14. The works should be completed within 06 weeks from the date of receiving of Work Order failing which a penalty @0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order Value. However, delay due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site etc., may/ may not be considered as may be decided by NIFT Authority.
