**Submission of Bids**

The interested firms should apply online and submit their bid along with scanned copies of all the relevant certificates, documents, etc. in support of their technical eligibility & price bids – all duly signed – on the Central Public Procurement Portal (CPP Portal) website <https://eprocure.gov.in> from 03/09/2022 to 22/09/2022 up to 3.30 P.M.

Applications to this bid will be accepted only through the online mode through the Central Public Procurement Portal (CPP Portal) website <https://eproccure.gov.in>. No other mode of application will be considered & application will not be accepted.

The Firm should ensure that it complies with the requirements as per works before applying for bid.

- a) **Technical Bid:** The technical bid must contain all the technical information (The all the document mentioned in the tender document should be scanned and uploaded in CPP Portal).
- b) Technical bid shall contain: Upload the original Tender Document (Except Financial Bid) Duly signed & Stamped on all pages of tender document as acceptance of tender conditions should be uploaded along with technical qualifying criteria, minimum turnover and as mentioned in the Part-I Technical Bid.

The Applicant to meet the following minimum experience:

Experience of having successfully completed similar works/Civil work during last 7 (Seven) years ending August, 2022, should be either of the following.

- One similar / civil completed work costing not less than Rs. 6.60 lakhs.
- Two similar /civil completed works costing not less 4.96 lakhs for each work.
- Three similar / civil competed works costing not less than 3.30 lakhs for each work.

#### **Bidder will be disqualified/black listed**

- i. The Bidder/Agency/Fir will be disqualified if:
  - a) Bidder withdraws his bid or backs out after acceptance.

#### **BID TERMS & CONDITIONS:**

1. Last date of submission of bid documents is through online **22<sup>th</sup> September, 2022 up to 03.30 pm.**
2. The EMD of unsuccessful bidders will be refunded within 60 working days after opening of price bid except lowest bidders. Bidders who satisfy the technical conditions stipulated in the bid document and who have enclosed all the documents / supplied materials required will alone be considered as qualified Bidders after the technical evaluation. The bids of such qualified Bidders will be considered for "Opening the Price Bid though CPP Portal". **For the items mentioned in Price Bid, the lowest Total price quoted on overall basis for all items. GST will be paid extra as per norms.** However NIFT reserves the right to reject any bid or all.
3. The successful bidder will have to deposit **5% amount of the total bid amount as Performance Guarantee within 10 working days of the receipt of work order** by a Demand Draft in favour of NIFT, payable at Mumbai at any branch of Scheduled Bank failing which the Work Order will be treated as cancelled. Bidder/firm/agency will be disqualified from participating in any future bid of the Institute and the EMD amount will be liable to be forfeited. No interest will be paid for Performance Guarantee Deposit.
4. The rate quoted in the price bid must be inclusive of all taxes, labour, material, loading/unloading, scaffolding/jhula etc. complete in all respect at site (**Excluding** GST which will paid extra as per norms). The rates will be valid for 120 days from the date of opening of financial bid document.
5. No bidder will be allowed to withdraw the bid rates after opening of the bid. If any bidder withdraws the bids/rates then his EMD amount will be forfeited and he will be disqualified from participating in any future bid of the Institute.

6. Rates should be offered unconditionally and if rates are submitted with any condition the bid liable to be rejected.
7. Bids with incomplete information subjective and conditional offers as well as partial offers will be liable for rejection.
8. NIFT reserves the right to reject any or all bid documents without assigning any reason thereof.
9. The agency should enclose self-attested copies of GST registration, letter of allotment of PAN/TAN Card under the Income Tax Act failing which bid will be liable to be rejected. Bidder will have to produce all these original documents at any time demanded by the Institute.
10. Payment of the work will be released after verification and satisfactorily completion of works.
11. Bidder must sign along with company seal on each and every page of the bid document as token of the acceptance of bid conditions.
12. If any malafide intention is observed by NIFT, the agency shall not be eligible for further bidding.
13. NIFT Mumbai reserves the right to change the quantity/ upgrade the criteria/ drop any item or part thereof/ extension of delivery date at any time before placing the work order.

15. Exterior wall crack filling work to be carried out through Spiderman jhula (Rope). Wherever the work is not possible to carry out through scaffolding for this no extra payment made. Required insurance to be taken for the workers and Spiderman jhula (rope).

17. Bidder/Agency/Firm should full responsibility of his worker safety as working area is the high rise building up to height of building 50.00 Rmt.
18. The interested agency is free to inspect the place on any working day from Monday to Friday during 10.00 am to 5.00 pm. Person visiting the campus must be either vaccinated or must be obtain negative RT-PCR Report

no. 20 of NIFT Mumbai at sector-4, Kharghar, Navi Mumbai” within the stipulated time, without prejudice to other remedies under the contract, a penalty equivalent to 0.5% (Half Percent) of the value of delayed works will be levied per week up to a maximum of 10% of the contract value. If requested by the bidder, it is the discretion of the Director, NIFT Mumbai to grant extension of time with penalty/without penalty.

20. The Contractor shall not be entitled to any compensation for any loss suffered by him on account of delays in commencing or executing the work, whatever the cause of delays may be including delays arising out of modifications to the work entrusted to him or in any sub-contract connected therewith or delays in awarding contracts for other trades of the Project or in commencement or completion of such works or for any other reason whatsoever and the employer shall not be liable for any claim in respect thereof. The Employer does not accept liability for any sum besides the bid amount, subject to such variations as are provided for herein.
21. Cost of EMD Rs.16,500.00 payable at NIFT Mumbai in form of Demand Draft in favour of NIFT or through NEFT/RTGS (details of fund transferred should be enclosed along with in the bid) and if Demand Draft it should be reach this Office by 22.09.2022 by 3.30 PM & it should be uploaded in the CPP portal along with Technical bids .
22. Cost of Performance Guarantee: 5% of total of bid amount will be held as Performance Guarantee with NIFT will be released after completion of work along with bill on request letter.
23. Security Deposit: 5% of Security Deposit will be deducted from the final billing amount and same may be released after completion of Defect liability Period (As DLP is one year) on submission of request letter.
24. EMD will be released after completion of work along with bill on request letter.
- 25. Forfeiture of EMD**
  - a) If Bidder withdraws the rate quoted by him
  - b) If Bidder has not accepted the “Acceptance of letter” within 7 days.
  - c) If Bidder has not deposited the Performance Guarantee amount at the rate of 5% of rate quoted by him after issue of “Acceptance of letter” within 10 days.
  - d) If any unavoidable circumstance or as per rule.
  - e) If Bidder modify or manipulate the prescribed Bid Form.
- 26. Forfeiture of Performance Guarantee & EMD**
  - a) If Bidder denied to accept the work order
  - b) If Bidder fail to execution of agreement on non-judicial stamp paper for value of Rs.100/-
  - c) If Bidder fail to start the work within stipulated time i.e. 10 days from the date of issue of work order.
  - d) If Bidder fail to complete the work within given time period.
  - e) If Bidder stop the work in between or fail to complete the entire work or part of work.
  - f) If Bidder not observing terms and condition of contract.
- 25. Forfeiture of Performance Guarantee, EMD both and Security Deposit**
  - a) If Bidder fail to complete the entire work
  - b) If Bidder not observing terms and condition of contract.



**25. Risks:**

Contractor shall be solely responsible for safety of his workers, working at site by following all safety norms in the trade.

All risks of loss or damage to physical property and of injury and death which arise during and in consequence of the performance of the Contract other than the excepted risks are the responsibility of the Contractor. Excepted Risks are:

- a. War, hostilities (whether war be declared or not), invasion, act of foreign enemies.
  - (ii) Rebellion, revolution, insurrection, or military or usurped power, or civil war,
  - (iii) ionizing radiations, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosive, or other hazardous properties of any explosive nuclear assembly or nuclear component therefore.
  - (iv) Pressure waves caused by aircraft or other aerial devices traveling at sonic or supersonic speed.
  - b. Loss or damage due to the use or occupation by the Employer of any section or part of the Permanent Works, except as may be provided for in the Contract.
  - c. Loss or damage to the extent that it is due to the design of the Works, other than any part of the design provided by the Contractor or for which the Contractor is responsible.
26. The successful bidder is bound to carry out any items of work necessary for the completion of the job even though such items are not included in the quantities and rates. Schedule of instructions in respect of such additional items and their quantities.
27. The successful bidder must bear in mind that all the work shall be carried out strictly in accordance with the Specifications made by the Engineer in charge / Employer and also in compliance of the requirements of the local public authorities and to the requirements of the local authorities and no deviations on any account will be permitted.
28. Before commencement of the work, Contractor needs to take measurement of the work, according to only material to be purchased and work to be executed. The quantities mentioned in the bid only are approximate. The NIFT is not responsible to pay the quantities more than bid quantities.
29. The Institute will not be responsible, if Agency purchased the material for full quantity as mentioned in bid and not binding to pay accordingly.
30. The execution area to be shown to the Contractor, after that contractor need to take measurement and quantities to be matched with bid quantities and work to be executed accordingly on permission of Engineer in charge.
31. After Completion of work, measurement will be taken jointly and matched with bid quantities, quantities should not exceed from the bid quantities. NIFT will not be responsible to pay for excess quantity.

32. The successful bidder shall make his own arrangement to obtain all materials required for the work. The successful bidder shall prepare a sample of the work and obtain the approval of the Engineer in charge to work further. No material shall be used without the prior approval of the Institute / Engineer in Charge. All those materials which are brought to site but are rejected by the Institute / Engineer in Charge, shall be removed from the site forthwith by the contractor peacefully /without any arguments.
33. Time allowed for completion of the work is 120 calendar days which shall be strictly observed by the bidder. The time shall be reckoned from the tenth (10<sup>th</sup>) day of written order to commence the work is issued.

**34. Contract Agreement:**

NIFT will notify the successful bidder that his bid has been accepted and it will send a work order to the bidder describing the works to be carried out and the same shall be returned duly acknowledged affirmatively by the bidder as a token of acceptance and a contract agreement will be signed between both parties on the agreement form. The contractor shall present the agreement on appropriate value of stamp paper for signature of NIFT Mumbai.

35. **Labour Laws:** (a) All the labour laws enacted by Ministry of Labour and Employment, Government of India which are implemented through the offices of the Regional Labour Commissioner (Central) such as, The Contract Labour (Regulation and Abolition) Act 1970; The Building and Other Construction Workers (Regulation of Employment and Condition of Services) Act 1995; Interstate Migrant Workmen (Regulation of employment of and condition of Service) Act 1979; The payment of Wages Act; The Minimum Wages Act; The Equal Remuneration Act; The Payment of Gratuity Act; The Payment of Bonus Act; The Industrial Disputes Act, 1947; Child Labour (Prohibition and Regulation) Act, 1986; The Maternity Benefit Act 1961 shall be strictly implemented by the contractor insofar as the same are applicable to this contract.  
(b) The offices of the Regional Labour Commissioner (Central), Mumbai and Navi Mumbai will have the jurisdiction over the implementation of the labour laws under this contract.
36. In case of any dispute raised by the supplier, a representation will be made only by the authorized representative of the supplier and the decision of the Director NIFT – Mumbai will be binding on the supplier. Dispute settlement board shall be formed of following members comprising of Director, Contractor representative, Finance head, Legal Officer, NIFT Mumbai.
37. In case of any dispute the Jurisdiction of Court will be Mumbai.
38. During works, care should be taken and other items should not be damaged.
39. The bidder requiring further information or clarification on the bid document may contact the Engineer in-Charge, NIFT, up to the closing date, during office hours only. The bidder must fill and submit the bid copy without making any additions or alteration in the bid document. Incomplete bids and those submitted not as per the instructions are liable to be rejected.
40. Bidder must be sign along with company seal on each and every page of the bid document as token of the acceptance of bid conditions.
41. Bidder must have to quote each item and quote all item and the quoted for part of item rates will not be considered and bid will be liable to be rejected. Compulsory to quote for all items.





42. If any damage is caused by the contractor to NIFT building or any other damage noticed during the work or otherwise should be made good by the contractor, or the expenditure incurred in this connection will be deducted from the payment of works bills.
43. Having read and understood all the terms & conditions of bid documents, I agreed to accept the same, if at any stage non-compliance has been observed at my end, NIFT, Mumbai will be having absolute right to terminate the contract, impose penalties or initiate legal proceedings, for which I shall remain liable.
44. The rates for all items of work, being current ones, will not be eligible for price adjustment due to increase or decrease in prices of materials and labor rates as per escalation formula, if any, given in the bid. If any of the items of work is omitted from the accepted bid at the sole discretion of employer, the contractor shall not be entitled to any claim on this account.
45. NIFT will not accept the price escalation, bidders should need to quote accordingly.
46. Workers/labours engaged to work should have full vaccinated or RT-PCR report should be produced during the inspection as per latest Covid-19 rules.
47. The bidders may question the bidding conditions, bidding process and/or rejection of its bid as per the Rule of the general financial Rule 2017. / CPWD work Manual.

**Risk and Cost:**

If bidder fail to complete the entire work or part of work in scheduled time, NIFT may assign the whole/balance to other agency at the risk & cost of bidder which could be high. In this case payment of the bidder will be released after adjustment of agency who will execute the whole/balance work. It may also adjust from the Performance Guarantee and security deposit of the bidder. Further, Performance Guaranty and Security Deposit will be forfeited. After adjusting all dues, loss to the NIFT and penalty for delayed work maximum up to 10% of work done, if any balance amount will be left out same will be released on request letter.

**TIME PERIOD:**

The total job should be completed within the time period as mentioned in the work order. The all works to be completed within 120 days. The total time period as mentioned for the completion of the job is to be strictly maintained and is the essence of the order. If the contractor fails to take up the work within a reasonable time or refuses to accept the work order or leave the job incomplete, NIFT Mumbai reserves the right to forfeit the security deposit as applicable and no more works will be issued to the contractor in future & Contractor will be Blacklisted.

**Neat & Clean Site:**

After completion of the work contractor shall leave the premises in neat, clean and tidy conditions as directed by the Employer. If the contract is terminated prematurely for any reason what so ever, the contractor shall peacefully hand over everything back to the Employer and leave the premises in neat, clean and tidy conditions

as directed by the Employer. The final dues of the contractors will be settled only after removal of all the debris from the site. In case of failure on the part of contractor to do so, the Employer will get it done at the risk, cost and consequences of the Contractor.

#### **TERMINATION OF CONTRACT**

1. If the bidder fails to complete the ordered work within stipulated time frame, the Institute will have the right to take up the ordered work from any other alternative sources and the contract of such firm/agency will be liable to be terminated and the EMD, Performance Guarantee and Security Deposit will be forfeited. The Institute will have the right to impose penalty for the delay in completing the ordered work and also to recover the excess amount would be involved for executing the ordered work from alternative sources from any dues payable to the contractor.
2. NIFT reserves the right to reject any or all bid documents without assigning any reason thereof.

#### **UNSATISFACTORY AND DEFECTIVE WORKS:**

1. Defective work is liable to be rejected at any stage. The contractor on no account can refuse to rectify the defects merely on reasons that the further work has been carried out. No extra payment shall be made for rectification.
2. The defective works if any carried out by the contractor shall have to be rectified as per the specifications without any additional payment towards such rectification. In case the rectification work is not taken up by the agency, the Performance Guarantee shall be liable to be forfeited and in all the matters, the decision of the Director, NIFT Mumbai will be final.

#### **OPTIONAL QUANTITY/ADDITIONAL WORK ORDER:**

NIFT Mumbai may increase the quantity of Work order/place additional work order at a later stage at the quoted rates. Actual quantities for executing the work will be given during award of work order.

#### **SELECTION CRITERIA:**

The work will be awarded to L1 vendor on overall basis. The determination of lowest bidder will NOT be on individual rates of financial bids. Rather it will be on overall basis of Grand Total of all items excluding GST which will be paid extra as per norms.

The following documents / information shall be attached along with Technical Bid as follows:-

- a. Copy of Pan Card.
- b. Copy of last latest two year ITR
- c. EMD Exempted for all bidders as per terms & condition of e-NIT.
- d. Experience Certificates/ Works Orders as mentioned in Clause no. Technical qualifying criteria.
- e. All NIT document shall be signed by contractor or partner or proprietor with rubber stamp of contractor/ agency and mobile no. attached with technical bid of e-bid.
- f. The technical bid should be filled online only.
- g. Financial bid should be filled online only
- h. The other terms and conditions shall be applicable as mentioned in NIT.
- i. GST registration certificate of the contractor/ agency / firm.
- j. The bid of any agency without above shall be rejected out rightly.

**PREAMBLE TO SCHEDULE OF QUANTITIES**

The following preambles shall be read in conjunction with the Schedule of Quantities. The rates / prices quoted in the Schedule of Quantities shall include:

1. Rates quoted shall include for all the safety precautions like temporary platforms / safety nets / jute or fishing net barricades etc. Rates quoted shall include for debris collections, erection of debris chutes, if necessary; taking away the debris outside the compound from time to time as directed by Engineer-in-Charge so as to keep the campus premises neat & clean, head load shifting etc. complete. In case the contractor does not keep the premises clean, the needful will be got done by the Employer at his cost, risk and consequences. The Running Account (R/A) Bills and Final Bill will be settled by the Employer after making all the recoveries/ deduction towards the expenses incurred by the Employer with regard to keeping the campus premises neat and clean.
2. The rate quoted shall also include for provision of necessary POP protection for entire flooring and skirting, clearing of the POP on completion of work, cleaning of the floor etc. complete whenever necessary and directed.

5. The rate shall include manually shifting of any material from work place to loading place and unloading to working place if any up to 1.00 Km or up to 2.0 Km are as per work location nothing extra paid in this regard and before quoting of rates the agencies need to visit the site and satisfy themselves.

27. No paint containing lead or lead products shall be used except in the form of paste or ready-made paint.
28. Suitable facemasks should be supplied for use by the workers when the paint is applied in the form of spray or surface having lead paint dry rubbed and scrapped.
29. Overalls shall be supplied by the contractor to the painters and adequate facilities shall be provided to enable the working painters to wash during the periods of cessation of work.
30. Hoisting machines and tackle used in the works, including their attachments, anchorage and supports shall be in perfect conditions.
