PREAMBLE / INTRODUCTION

National Institute of Fashion Technology (NIFT) is a premier educational institution set up under an Act of Parliament and functioning under the aegis of the Ministry of Textiles, Govt. of India. The Mumbai centre has been set up since, 1995 with undergraduate and post graduate programmes.

Tender Notice:

NIFT invites E- Tenders under one Bid systems for "Providing of Catering Services for NIFT Convocation 2023" at NIFT Campus. Plot No.15, Sector-4, Kharghar, Navi Mumbaias per the quantity and item mentioned in financial bid (Annexure "B"). The tender bids duly-filled in all respects enclosing necessary documents and submit the hard copies of bid document manually to following address:- The Joint Director, National Institute of Fashion Technology, Plot No.15, Sector -4, Kharghar, Navi Mumbai – 410 210. The bids to be submit ion **or before** <u>3:00 PM</u>, **on** 04.12.2023.

Technical Qualifying Criteria:-

- 1. NIFT proposes to invite limited tenders for "Providing of Catering Services for Convocation on 9th December 2023 at the Venue:- NIFT Campus, Plot No. 15, Sector-4, Kharghar, Navi Mumbai. The tender should be single bid system Technical cum Financial bid, one for the <u>Technical bid</u> (as per annexure 'A',) and another one for the <u>Financial bid</u> (as per Annexure 'B') and hard copies are also required to be submitted with one envelope which should be clearly super scribed on the envelopes. These sealed covers are to be put in a bigger cover which should also be sealed & duly super scribed as Tender for "Providing of Catering Services for NIFT Convocation 2023".
- 2. The date of event is scheduled for 9th December 2023 and Venue:- NIFT Campus, Plot No. 15, Sector-4, Kharghar, Navi Mumbai.
- 3. Tender shall be uploaded in official tender form only. If submitted in any other form the same shall be summarily rejected.
- 4. Tenderer shall enclose a demand draft / pay order for an amount of **Rs.21,000/-** drawn in favour of NIFT Mumbai payable at Mumbai as the non-interest bearing **Earnest Money Deposit (EMD).** If the agency has registered with MSME/NSIC the EMD charges will be exempted after uploading the Certificate of the same.

- 5. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instruction laid down herein: otherwise the tender is liable to be ignored. Further, tenderer must sign all the pages of the tender document and should be upload in the respective envelopes by online.
- The tender should be uploaded on or before <u>3:00 pm on 04.12.2023</u>. The Technical cum financial bid will be opened on the same day i.e on 14.12.2023 at 3.30 pm in CPP Portal Site.
- 7. NIFT shall in no way be responsible for any default with regard to any statutory obligation and the vendor/contractor will indemnity NIFT in case of any damage or liability, which may arise on account of action of the firm.
- 8. Offers received without EMD shall be summarily rejected.
- 9. The EMD to other than lowest bidders will be returned within two weeks of opening of tenders.
- 10. The successful tenderer will have to deposit 5% of the total bid amount as security deposit and this will also be treated as Performance Guarantee. Part of this amount will be adjusted against the EMD deposited by the tenderer along with the tender form. The balance amount will have to be deposited by the successful tenderer within 5 working days of the receipt of the work Order by a Demand Draft in favour of NIFT Mumbai, payable at Mumbai at any branch of Scheduled Bank failing which the work Order will be treated as cancelled and the EMD amount will be liable to be forfeited. The successful bidder's Security Money will be returned after successful completion of event and after adjusting dues, if any.
- 10. Tender shall be accompanied by the relevant documents including Annexure "A" list of organizations where the supplier/agency has currently provided/serviced the items covered in the tender.
- 11. These rates will be valid for 180 days from the date of opening of tender document.
- 12. No tenderer will be allowed to withdraw the tender rates after opening of the tender. If any tenderer withdraws the rates the EMD amount deposited by him/her will be forfeited and he/she will be disqualified from participating in any future tender of the Institute.
- 13. Rates should be offered unconditionally and if rates are submitted with any condition the tender liable to be rejected.
- 14. The catering agency should have the experiences of at least 03 years for similar works/services for conducting the Catering Services for more than 800 peoples for reputed Colleges or Schools or fashion events/ organizations etc.

- 15. The full & final payment shall be made on the successful completion of the event, on production of satisfaction certificate from the Committee. subject to statutory deductions.
- 16. The bill will be settled within 15 days of the date of submission of bills.
- 17. The agency shall ensure that himself / herself or his / her authorized representative is available for proper handling the serviceat **NIFT Campus, Plot No.15, Sector-4, Kharghar,Navi Mumbai.**
- 18. The agreement will be valid for the delivery as incorporated in the tender document. This should be strictly adhered to.
- 19. NIFT reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the commercial bid.
- 20. The specification of items required as per Annexure/Schedule and the evaluation of bid will be on the basis of <u>total bid value</u>. The rates quoted should be inclusive of GST and charges. The rates quoted should be on the basis of free delivery and execution of the work/services at venue.
- 21. The rates quoted should be on FIRM & FIXED basis. No additional payment will be made other than quoted in this tender.
- 22. Price may be quoted on per unit basis for the items as per Annexure "B". Delivery and Services is required 9th December 2023 at the venue: NIFT Campus, Plot No. 15, Sector-4, Kharghar, Navi Mumbai.
- 23. The Work Order shall be issued by NIFT, Mumbai and services shall be arranged by the agency at **NIFT Campus, Plot No.15, Sector-4, Kharghar, Navi Mumbai.**
- 24. They should be registered for GST and should enclosed copies of relevant certificates along with technical bids.
- 25. Firms must clearly indicate in their offers the different taxes and charges which they propose to charge mentioning clearly the present rate(s) thereof. Vague offers like "duties as applicable" shall not be considered.
- 26. In case of any dispute raised by the agency, a representation will be made only by the authorized representative of the agency and the decision of the Director NIFT Mumbai will be binding on the agency. The jurisdiction of Court will be Mumbai.
- 27. For items mentioned at Annexure "B", the bidders must ensure the required quality and quote accordingly. In case items are not served the same as quoted they shall not be accepted. No payment/claims for such items shall be entertained.
- 28.NIFT will provide the kitchen space & tables & chairs for food counters to the agency.

- 29. Food items should keep in the venue very hygiene and serve accordingly.
- 30. Supporting staff/Serving people should wear the cap, gloves and mask etc.
- 31. The Catering agency should provide the plates, glasses etc. for dinner.
- 32. The agency should provide the "Dinner"as per the menu mentioned in the Annexure "B".
- 33. Time for providing of "Dinner" for the event will be confirms prior 2 to 3 days before the event.
- 34. The Contractor shall not appoint any sub-contractor to carry out his obligation under the contract.
- 35. The quantity given in the tender offer may be increase or decrease or withdrawn as per actual requirement. The payment will be made accordingly.
- 36. Event management is expected to organize the event of very high standard and keep entire area and surrounding area neat and tidy.
- 37. The menu of the dinner for the event should be provided as per Annexure"B".
- 38. The payment will be made as per actual quantity of food served for the event if quantity of food may (Increase/Decrease).
- 39. Penalty If the performance of the agency is not satisfactory then a penalty of maximum upto 5% of the awarded value of work shall be levied on the agency based on recommendation of inspection committee or authorized representative nominated by competent authority of NIFT Mumbai.
- 40. Post event it will be responsibility of the agency to deploy their own manpower for transportation of food items& cleaning of premises. The payment shall be released only after inspection to the effect that agency has should keep the campus in neat & clean manner.
- 41. The bidder may quote for the items given in this tender document. However, since it is an auspicious & big event where many high profile dignitaries are invited us guest there are slight chances that same additional food items shall be required to provide by the agency. All such additional required material shall be provided by agency only after prior approval of NIFT & the payment shall be strictly done on the basis of executed quantity.
