CE PROGRAMME ADMISSION GUIDELINES/PROCEDURE Academic Year: 2025-26 (For Mumbai Campus)

NIFT Mumbai Continuing Education Programme

National Institute of Fashion Technology, besides conducting regular professional undergraduate and postgraduate programmes in Design, Management and Technology, also offers short duration part time evening / weekend courses under Continuing Education (CE).

ADMISSION PROCEDURE:

1. Submit the CEP (Continuing Education Programme) Admission Form, along with the passport size photograph pasted in the specified area. (Download application form from https://nift.ac.in/mumbai/continuing-education).

Registration can be done manually by downloading the registration form available online. The completed filled in registration form/printout of the filled-in registration form, complete in all respects should be submitted only at the NIFT Mumbai Campus by the candidate through post/courier subscribed "CE Registration form:2025-26" along with Demand Draft.

2. Submit the Admission Form along with photocopies of the Qualification certificates (must be self-attested).

The eligibility criterion for all the CE Programmes are 10+2 minimum education. The eligibility criteria for E-commerce for Fashion Business course (Online) is minimum 10+2 with basic computer knowledge.

3. DEMAND DRAFT or ONLINE PAYMENT FOR REGISTRATION

The application fee can be paid through DD. All demand drafts have to be drawn in favor of "NIFT MUMBAI" payable at Mumbai.

For Online Payment, please mention the Online Transaction Number with the date and the amount in rupees along with the Name of the Bank and Branch.

- REGISTRATION FEE FOR ONE YEAR PROGRAMMES IS Rs.2150/- + 18%GST, TOTAL FEE IS Rs.2,537/- (Non-Refundable)
- CEP COURSE REGISTRATION FEE FOR SIX MONTHS DURATION OR LESS IS Rs.1200/- + 18% GST TOTAL FEE IS Rs.1,416/-(Non-Refundable)

Please fill the details of the fee payment in the admission form. In case of demand draft, the name of the candidate, phone/mobile No. E-mail id, name of the programme are to be clearly mentioned at the back of the bank draft.

4. Three latest passport size candidate photographs, one for the student Identity Card, Resource Center Card and for NIFT Records.

PERSONALINTERVIEW

Upon successfully receiving serial No.1,2,3,4 the Interview panel/course coordinator at NIFT Mumbai will conduct a personal interview with the candidates. (It is at the discretion of the coordinators, Personal Interviews can also be conducted online if required). The date of the interview will be intimated to the candidate by the respective CE Programme coordinator over telephone/E-mail id.

A candidate is judged on the various parameters as listed below by the interview panel in the personal interview:

- Career orientation
- Aptness for the field
- Overall personal achievements in academics and co-curricular activities.
- Communication
- General awareness and aptitude, creative and lateral thinking are likely to be useful.

During the interview, the candidate should show their original certificates to the course coordinator.

The candidates will be selected on a provisional basis and the final selection will be after the verification of the original certificates by the course coordinator and after receiving the total course fee, before the course commencement date.

6. COUNSELING:

The details of the interview results will be informed personally through an E-mail by the respective course coordinators.

After the selection in the CE Programme, the candidates need to pay the full course fee and resource center fee.

7. DEMAND DRAFT FOR TUITION FEE & RESOURCE CENTER FEE (After the Selection)

All demand drafts have to be drawn in favour of "NIFT MUMBAI" payable at Mumbai.

RESOURCE CENTER (RC) FEE:

- For CEP with 6 moths or lesser duration: **Rs.2,500/-** + Rs.4,000/- (Rs. 4,000/- will be refundable as security deposit)
- More than 6 months duration: Rs.4,000/- + Rs.5,000/-(Rs. 5,000/- will be refundable as security deposit)

TUITION/COURSE FEE:

The name of the candidate, phone/mobile No. E-mail id, name of the programme are to be clearly mentioned at the back of the bank draft if the registration fee is paid through the bank demand draft.

Submit Serial No. 7 as mentioned above to the NIFT Mumbai address by post/courier.

In case you courier/post the Tuition/RC fee DDs along with other documents to NIFT Mumbai, please mention "CEP Admission 2025-26" at the top of the envelope couriered.

8. Candidates appearing in the qualifying examination such as 12th class/final year/final semester (as the case may be) are also eligible to apply to CEP provisionally, subject to the following conditions:

Those candidates who are seeking provisional admission due to non-declaration of their qualifying examination will provide proof of having passed all papers in all the previous years/semesters (whichever is relevant).

The candidate will submit the final result of the qualifying degree/certificate providing his/her eligibility as and when the results are declared to their CEP Programme coordinators /CE Programme advisors at Campus, where the admission has been granted on or before the course starts.

In case a student attends a programme but fails to qualify for the qualifying examination no certificate will be issued and no course fee will be refunded.
