**NOTICE**

NIFT has been providing financial assistance to its meritorious, needy and deserving student who comes from economically weaker section under the prevailing **Means-Cum-Merit Financial Assistance Scheme**.

**Eligibility Criteria for application:**

The students who fulfill the following criteria may apply for the financial assistance under this Scheme :

1. Undergraduate and Postgraduate students of the regular programme of NIFT excluding those admitted under NRI/ NRI sponsored category.
2. All the eligible first year students may apply irrespective of their ranks and marks in the entrance exam
3. The students fulfilling the criteria of parental income slab as stipulated below:

**Process of issuance and submission of form:**

1. Financial assistance application forms may be obtained from the NIFT website [www.nift.ac.in](http://www.nift.ac.in) & NIFT Patna website [www.nift.ac.in/patna](http://www.nift.ac.in/patna) along with the rules and regulations.
2. The forms completed in all respect with supporting documents, in prescribed format should be submitted by **30th August, 2018** to the CC-FP

**Mandatory documents (required to be submitted)**

- i. One copy of passport size photograph with signature
- ii. Income declaration-affidavit (Format B) on non-judicial stamp paper of 10 (Rupees Ten) by each parent
- iii. Proof of permanent residence
- iv. Photocopies of Passport and PAN card of parents / guardian and applicant (In case the students and parents do not possess the PAN Card and Passport or either, the students are required to submit affidavit.)
- v. School leaving certificate for class X and XII (Proof of school fee, wherever possible)
- vi. The copy of receipt of tuition fee paid for the current semester i.e. July -December
- vii. Schedule (Format C - details of agricultural land and property, etc.) duly signed by parent with relevant revenue record
- viii. Bank statements for the last 12 months for all the accounts mentioned in Schedule (Format C)
- ix. Educational loan details [sanctioned or denied] by bank in the prescribed format (Annexure-I)

**Other Documents (If applicable)**

- i. 3 year's Income Tax returns copy/Form 16 for salaried / 16 A for business owners
- ii. Vehicle registration copy
- iii. Tehsildar certificate of agriculture land along with certified revenue records such as khasra, khatouni
- iv. Documents related to others scholarship / sponsorship receipt
- v. Document related to SC / ST / OBC / PHP certificate

**Kindly Note:**

1. A student seeking financial assistance is required to first apply for educational loan. If he or she is denied educational loan by bank, then his or her request for Mean-Cum-Merit Financial Assistance Scheme of NIFT would be taken up. A student, who does not submit educational loan details or he/she is not pursuing educational loan seriously, then he or she is not entitled for financial assistance.
2. No request will be entertained to any extent after **30th August, 2018** regarding submission of the said application form.
