### Sub: Tuition Fee for the Session Jan to June 2021

**Tuition Fee payment through CMS has been introduced among all NIFT Campuses. The Student has to pay their fee through CMS Payment Gateway only.**

It is requested to note the following:

1. Last date of depositing the fees for the session Jan 2021 to June, 2021 is **8<sup>th</sup> February, 2021**. Fee with a late fine of Rs. 100/- per day plus GST@18% can be deposited till **19<sup>th</sup> February, 2021**.
2. The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date.
3. Students will be required to pay their current semester fees (Tuition Fee) through CMS Payment Gateway only (as per information provided above).

4. The student who has availed bank loan/scholarship facility may contact accounts department of the campus for further details and may instruct their banker/scholarship sanctioning authority to remit fee in the following manner [either option (a) or option (b)] :

(a) Pay current semester fees (Tuition Fee) through Demand Draft (in favour of "NIFT, Patna", payable at Patna)

(b) Pay current semester fees through NEFT/RTGS, (BANK A/c no:- 529602050021023, A/c Name-NIFT PATNA GENERAL ACCOUNT, Bank IFSC code: - UBIN0552968, BANK BRANCH: - Exhibition Road Patna). **The student has to update his/her fee payment details in CMS and mandatorily submit the transaction details in the prescribed format along with transaction receipt.**

5. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their Department before the commencement of the session and to complete the formalities. Repeat students will be required to pay the **re-registration fee of Rs.10,000/- plus GST@18%** per absencing semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above the mentioned amount.
