- 3.3 Vendor/service provider has to provide/arrange the utensils, fuel, LPG and all other basic items required for running the canteens. Items to be stocked and sold (in good variety, quality and quantity):
- 3.4 All safety-related measures, such as fire extinguishers and other precautions, must be ensured by the selected vendor.".
- 3.5 Food & Tea/Coffee & Snacks, Fruit & Juice Shops (including kitchen):. Items mentioned at Annexure 'A' are to be served. For smooth running of food canteens, service providers should have sufficient number of cooks and serving staff on their rolls to prepare and serve good quality meals. (Tentative Menu is attached at Annexure A).

Fruit and Juice : Various types of seasonal fruits and **Fresh Fruit Juice**, to be sold/prepared and served in disposable/glassware, on demand basis in a clean and hygienic way.

Tea/Coffee, Snacks: Various types of tea, coffee, juices, and soft beverages of multiple brands. Usual snacks like samosa, bhajiya, bread pakoda, chowmein, poha etc. (at economic price and the packaged food not more than MRP price)

- 3.7 Only NIFT Patna fraternity will access the facilities.
- 3.8 The vendor must provide the tentative list of items with the minimum prices for the tentative food items enclosed. The lowest price of items and the highest rental will be considered for vendor selection

- 3.12 The selected vendor must provide a bill, coupon, receipt etc to the students after receiving of amounts.

- 3.15 Sub-letting in any form will not be permitted.
- 3.16 The initial tenure of engagement of Vendor/Service provider shall be for one year which may be extended for further year on the basis of performance evaluated by the Institute.

- 3.17 Any additional items apart from the submitted menu list must be approved in advance by the Competent Authority.
- 3.18 If the selected vendor engages in malpractice or overpricing of food, NIFT Authorities may impose a minimum fine of Rs.10,000/-.
- 3.19 NIFT will not be liable for any kind of loss by any natural or accidental reasons.
- 3.20 The Selected vendor must ensured other compliances like Insurance, Fire Safety and for others unforeseen loss.
- 3.21 Security deposit of amount Rs. 30000/- must be submitted before starting of the Food & Tea/Coffee & Snacks, Fruit & Juice Shops.
- 3.22 Vendor will be take sole responsibility of cleaning of service and serving
- 3.23 Waste material management also be ensured by the vendor.
