1. Last date of depositing the fee for July-December, 2018 is **10<sup>th</sup> September, 2018**. Fee with a late fine of Rs. 100/- per day can be deposited till **20<sup>th</sup> September, 2018**.
2. Last date of depositing the fees for the session January to June, 2019 is **28<sup>th</sup> January, 2019**. Fee with a late fine of Rs. 100/- per day can be deposited till **5<sup>th</sup> February, 2019**.
3. The name of the student will be struck from the institute rolls without any further notice due to non-payment of fee after the specified date.
4. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their concerned campus before the commencement of the session and to complete the formalities. Such students will be required to pay the re-registration fee of Rs. 5000/- per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee besides the above mentioned amount.

**HOSTEL FEE**

Hostel fee will be applicable to all the hostellers (Boys & Girls) of NIFT, Raebareli Centre for the academic year 2018-19 (**except 7<sup>th</sup> semester of FC, AD & LD and 3<sup>rd</sup> Semester of MFM**). Hostel Fee break –up is as under.

- I. Hostel Fee (Including Mess Charges) should be deposited by the new students who took admission in the Academic Year **2018** by **25<sup>th</sup> July, 2018 (on the date of reporting)**. The allotment of Hostel will be allowed after depositing full Hostel Fee (Including Mess Charges) i.e. **Rs.89,900/-** in the form of Demand Draft (DD) only in f/o NIFT payable Raebareli.
- II. Hostel Fee should be deposited by the old students by **10<sup>th</sup> September, 2018**. Fee with a late fine of Rs. 100/- per day can be deposited till **20<sup>st</sup> September, 2018**. The student will be debarred from the Hostel without any further notice due to non-payment of fee after the specified date.
