1. The contract will be for period of Six months.
2. The candidate should ensure that they fulfill the eligibility (qualification, experience etc.) criteria as mentioned above. NIFT Raebareli reserves the right to fill or not to fill any/all the positions advertised or postpone the same without assigning any reason.
3. The CV in the prescribed format must contain passport size photo, details of educational qualification, Work experience in Industry/ teaching etc. date of birth, awards and complete contact details (Permanent address & Correspondence details) including mobile number, email etc.
4. Maximum age for applying for the above mentioned positions is 55 years as on the last date for receipt of the CVs. Interested and eligible candidates may send their detailed CVs to **establishment.raebareli@nift.ac.in within 15 days from the date of publication of advertisement.**
5. Apart from teaching, the selected candidate may be given additional academic / administrative responsibility pertaining to the NIFT Raebareli / Extension Centre of NIFT Raebareli at Varanasi.
6. All correspondence with the candidate shall be sent through email ID provided by him / her in his / her CVs.
7. Employees of Government Departments and/or PSUs/ Autonomous Bodies under Government will be considered only after submission of No Objection Certificate (NOC) from the employer.
8. Scrutiny of the CVs will be done ascertaining the eligibility & suitability of the candidates. Only shortlisted candidates will be considered/ called for the further selection process / interview.
9. Selected Candidate will be entitled for 1 day Casual Leave for each 1½ months of completed service and 2½ days Earned Leave for each month of completed service. No other kind of leave will be admissible.
10. The consolidated salary for Short Term Contract Faculty is Rs. 55,000/- (No other allowances are admissible).
