IMPORTANT INSTRUCTIONS TO STUDENTS:

1. PG Students of 3rd semester will be required to pay the Alumni Association Membership Fee (One time) (Non refundable) of Rs. 5900/-
2. After striking off of the name of the student from the NIFT rolls due to non-payment of fee with or without fine, if the student still wants to continue studies in NIFT, the student would have to pay a re-registration fee of Rs. 10,000.00 + 18% GST, i.e. Rs.11,800/- as applicable over and above the semester fee, within the next 15 (fifteen) calendar days after the notified last day for depositing fee with fine. The student will be allowed back into class only after receipt of full fee.
3. It will be the sole responsibility of the student concerned to achieve the minimum required attendance by the end of the semester as per the NIFT policy. No attendance relaxation will be given in this regard
4. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their concerned department before commencement of the session to complete the rejoining

formalities. They will be required to pay the re-registration fee of Rs. 10,000.00 + 18% GST, i.e. Rs.11,800/- as applicable for each absenting semester as well as non-refundable annual charges towards library and Student development, Medclaim & Exam fee over and above the mentioned amount.

5. If a student appears in re-examination/re-jury or gets withheld result, the student shall pay the fees for the next semester once he/she clears the re-examination/re-jury. The students declared 'pass', shall pay the fees within 1 (one) week of declaration of the re-exam/re-jury result without fine. In this case, the date of declaration of result will be considered the first day for depositing the fee. Afterwards, the semester fee is to be paid with fine at the rate of Rs. 118 per day (including 18% GST), within next 7 (seven) days after the last date of payment of fee without fine. On non-payment of the fee, after this 2 (two) week duration, the name of the student would be struck off from the rolls of the institute without any further notice.
6. The students shall not be allowed to join the course if the fee is not paid by the due date with fine. Any delay in payment of fees beyond the dates specified in the academic calendar would result in the name of the student being struck off the rolls of the institute.
7. The late fee is to be paid in full with fine within 15 (fifteen) days from the last date of payment of fee, as specified in the academic calendar.
8. Semester fee, once deposited, shall not be refunded except the security deposit which will be refunded upon completion or withdrawal from course/permanent transfer to other NIFT Campus based on request from the students to be submitted in the No Dues Form available with accounts department and to be submitted within one year from the date of completion / withdrawal as per NIFT rules
9. Students availing education bank loan are required to submit their request in the prescribed bonafide form to academics.shillong@nift.ac.in after declaration of the end term examination results. Further, processing of bonafide applications requires processing time of 2-3 working days and therefore students are advised to submit the same at the earliest.
10. No fee will be accepted by cash, cheques and in instalments.
11. Students who withdraw after start of academic session without payment of academic fee before or after the due date fixed by the Institute the Security deposit paid by the student at the time of admission or allotment of hostel shall be forfeited.
12. Please note that under no circumstance, request for extension of date for remitting of fee/waiver for payment of penalty will be entertained as the dates are fixed by NIFT Head Office and is applicable to all the students of NIFT across all the centres without exception.
