TERMS & CONDITIONS:

- 1. New Hostellers need to deposit a security deposit of Rs.3000/- in addition to the above fee. The refundable component of security deposit will be refunded based on request from the student with the consent of the parents upon completion/ withdrawal from hostel/course/permanent transfer only to other NIFT campuses in the no dues form available with the respective departments and to be submitted within 6 months.
- 2. For new admissions, the seat allotment would be on first come first serve basis and on the basis of confirmation of the date of hostel fee payment i.e. whoever pays hostel fee first to the Accounts Department as per the bank details provided.
- 3. For all other students, the last date to deposit the Hostel fee for the existing hostellers is 07/08/2023.
- 4. Students will be allowed to join the hostel only after payment of full hostel fees.
