National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 19 centers. It provides four years undergraduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education Program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raibareli, Shillong, Srinagar, Panchkula, Varanashi and Daman. National Institute of Fashion Technology NIFT, Shillong was established in 2008.

The Technical Bid & the Financial Bid (BOQ) in Excel format should be applied online separately. The Technical bids will be opened as per the schedule during which tenderer or its authorized representative(s) may remain present at their discretion.

1. SCOPE OF WORK

- 1. The vendor will be required to deliver the items at destination and installed the water purifier at NIFT, Shillong price for which is inclusive with the water purifier.
- 2. The successful vendor should be responsible for rectifying any defect during the warranty period.
- 3. The Warranty for the Water Purifier to be provided for a period of one year.

- (a) The interested firms should apply online and submit their tender and the bids along with scanned copies of all the relevant certificates, documents, etc. in support of their technical & price bids on the https://eprocure.gov.in/eprocure/app (Central Public Procurement Portal). - (b) Applications to this tender will be accepted only through the online mode. No other mode of application will be considered & application will not be accepted.

2. GENERAL TERMS AND CONDITIONS

- 1. Please read the terms & conditions carefully before submission/filling up the document. Incomplete tender documents will be summarily rejected.
- 2. The vendor should have experience for supply of water purifier, Attach two order copy of the Work order/Supply order.
- 3. All tenderers are required to submit **Earnest Money Deposit (EMD) of Rs.10,000**/- (refundable) (should be drawn beyond the date of notification of this NIT) in favour of NIFT Shillong payable at Shillong. Bidders can also submit the EMD with Payment online through RTGS / internet banking in Beneficiary name NIFT, General Account Account No. 385002050000002 IFSC Code

UBIN0538507 Bank Name Union Bank of India Branch address G S Road Shillong. No interest shall be paid on the said EMD and will be returned/Adjusted with Security deposit after finalization of the tender; however, the EMD of the successful bidder will remain with NIFT and will be forfeited in the following events:

- a. If information declared/document submitted found false/fake/forged
- b. If the selected/successful bidder does not accept the W.O., or, unable to provide service
- c. If the bidder withdraws his bid/quote.

Those who are exempted from submitting EMD should submit valid document issued by the concerned authority (viz. NSIC/MSME/Startup etc.).

- 4. The name and address of the bidder shall be clearly written in the space provided for the purpose and no over-writing, correction; insertion shall be permitted in any part of the tender unless duly countersigned by the bidder. The tender should be filled in and submitted strictly in accordance with the instructions contained therein; otherwise the Tender is liable to be rejected.
- 5. The Financial bids submitted by all bidders should be valid for at least for a minimum period of three months (90) Days from the date of opening of Technical Bids.
- 6. Canvassing in any form will make the tender liable to rejection upfront.
- 7. All payments made to supplier will be subject to applicable Tax Deduction at Source.
- 8. Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.
- 9. The defective product shall be replaced by the agency without any additional charge during guarantee period of supply. The replacement shall have to be carried out within 15 days of the intimation being received from the Institute.
- 10. The catalogue/ Brochure for the Item quoted by the vendors should be enclosed along with technical bid. Model quoted & details specification.
- 11. NIFT does not bind itself to accept the lowest tender. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order at the sole discretion of NIFT.
- 12. The Water Purifier should be delivered, placed, installed and commissioned at NIFT Shillong, within a stipulated period of 4 to 6 weeks from date of issue of letter of award. If the tenderer fails to supply the ordered quantity within the stipulated time period/ supplies sub-standard item, liquidated damages equivalent to LD of 0.5% of total order Value per week of delay, maximum upto 5% of Contract Value is applicable.
- 13. Payment of the supply will be released after verification, installation of equipment and related accessories, successful demonstration of the equipment, certification of satisfactory installation by the user department and on the production of original invoices

- 14. Any query/clarification with respect to the tender (T&Cs, etc.) may get cleared prior to submission of bid; concerned NIFT official(s) may be contacted (0364-2308829/26) in this regard in between 10.00 am to 5.00 pm on any working day). However, NIFT will not entertain or clarify any such query duringpost bid.

- 16. Force Majeure: The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delays in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

 For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics,
 - If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 17. MII as per instructions contained in the Order's No.P-45021/2/2017-B.E.-II dated 15th June 2017 circulated/issued by Government of India, Ministry of Commerce and Industry, Department of Industrial Policy and Promotion, Udyog Bhawan, New Delhi in pursuance of provision of Rule 153(iii) of General Financial Rule 2017, to encourage "Make in India" and promote manufacturing and production of goods and services in India, preference will be given to local supplier/bidder meeting the criteria prescribed in the above said order. All the instructions mentioned therein will be adhered. No representation/request of any firm(s) against the decision taken by the Dept. In pursuance of these orders/instructions will be entertained at any stage on any ground whatsoever it is.

3. EVALUATION OF FINANCIAL BIDS

- 1. Even after qualifying in the technical bid, the financial bid may be rejected if found not in order.
- 2. In case of L-I is more than one, the selection criteria [viz. the past performance, turnover, etc. would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such a situation, will be final in all respect and will be binding on all the tenderers.
