SUBJECT: ENGAGEMENT OF ONE YOUNG PROFESSIONAL (YP) IN NIFT

INTRODUCTION

Set up in 1986, NIFT is the pioneering institute of fashion education in the country and has been in the vanguard of providing professional human resources to the textile and apparel industry. Over the years, NIFT has also been working as a knowledge service provider to the Union and State Governments in the area of design development and positioning of handlooms and handicrafts.

National Institute of Fashion Technology (NIFT) invites Expressions of Interest (EOI) from eligible candidates for the position **"Young Professional"** for attending to specific and time-bound jobs in the Administration Department of NIFT, Head Office, New Delhi. Only persons with requisite qualification and experience as prescribed would be engaged as Young Professional. The details of the Advertisement are as under:

1. EDUCATIONAL QUALIFICATION AND EXPERIENCE:

Under Graduate degree from recognized University / Institution with at least five (05) years' experience in any Government Organization not below position of Assistant.

2. AGE LIMIT:

Not exceeding 35 years

3. TENURE:

The initial contract period of the YP will be 1 year, extendable by another year based on performance review at the end of 1st year. Thus, the maximum contract of a YP is 2 years.

The engagement of Young Professional is of a temporary nature and the engagement can be cancelled at any time by NIFT without assigning any reason. Young Professional, so engaged, would be required to serve one month's notice to NIFT before leaving organization, in case the YP is desirous of leaving without completing full tenure of engagement.

No work experience letter will be given in case the YP leaves on his/her own accord before completion of 1 year.

4. REMUNERATION:

All inclusive remuneration shall be Rs. 40,000/- per month. The Young Professional will be entitled to an annual increment of 5% in his remuneration, in case the tenure is extended. **TA/DA:** As applicable to NIFT Employee in Level-06

5. Working Hours and Leave:

- a). Working Hours shall normally be from 9.00 AM to 5.30 PM during working days including half an hour lunch break in between. However, in exigencies of work, YP may be required to sit late and may be called on Saturday / Sunday and other holidays also. Such late sitting or working on close holidays on exigencies will not attract any additional remuneration.
- b). Paid leave shall be granted at the rate of 1.5 days for each completed month. Accumulation of leave beyond calendar year will not be allowed. Moreover, the absence up to one month for any valid reason will be considered without remuneration.
- c). Apart from above, the women YP may be eligible for maternity leave as per the maternity Benefit (Amendment) Act, 2017 issued by Ministry of Labour & Employment vide letter No. S-36017/0302015-ss-I dated 12th April, 2017.

IMPORTANT INSTRUCTIONS

- 1) **No TA/DA** is permissible for participating in the selection process.
- 2) Any discrepancy found between the information given in application and as evident in original documents will make the candidate ineligible for appearing in the selection process.

3) SELECTION PROCESS:

- Initial Screening: Evaluation of submitted documents to ensure candidates meet the eligibility criteria.
- Shortlisting: Shortlisted candidates will be invited for an interview and presentation of their portfolio.
- Interview: Evaluation of candidates' experience, and suitability for the role.
- Final Selection: The final decision will be based on the overall assessment of the candidate's qualifications, experience, and performance in the Presentation and Personal interview or any other Selection criteria fixed by the NIFT. The decision of NIFT shall be final.

The dates and mode of Presentation / Interview will be communicated through email to the shortlisted candidates. The mode of interview / interaction may be either offline or through online mode which will be at the sole discretion of the Competent Authority.
