With reference to your revised proposal dated 22nd April 2021, the Competent Authority of NIFT is pleased to inform you that your proposal to provide services for design, development, implementation and maintenance of a digital platform for the RTC Project of NIFT Head Office has been accepted as per details given below:

- CDAC has been appointed as the technology service provider for design, development, implementation and maintenance of a digital platform for the Repository for the RTC project of NIFT titled The Repository Indian Textiles and Crafts (RTC) based on the revised proposal for a service contract of two years extendable by another one to three years subject to availability of the additional budget.
