WITHDRAWAL –ADMISSIONS 2026

As per the Counselling Guidelines, the last date for withdrawal from the Admission Process 2026 is 17th July 2026 (up to 12:00 Midnight) for all candidates.

Candidates who submit their withdrawal request on or before 17th July 2026 (12:00 Midnight) shall be eligible for a refund of the entire fee paid, after deduction of the Registration Fee, in accordance with the prescribed rules.

Candidates submitting withdrawal requests after 17th July 2026 (12:00 Midnight) shall forfeit the entire fee paid and only the Security Deposit shall be refunded.

All withdrawal requests must be submitted exclusively through the Admission Portal. Requests submitted offline through e-mail or by any other mode shall not be entertained.

For the convenience of candidates, the refund provisions as stipulated in the Counselling Guidelines are reiterated below:

1.	Withdrawal Request received on admission portal till 17 th July, 2026 upto 12.00 midnight	Full fee except Registration Fee of Rs. 9300/-
2.	Withdrawal Request received after 17 th July, 2026 onwards	Only Security Deposit will be refunded.

Withdrawal from Admission after 28th July, 2026

In case a candidate seeks withdrawal and refund after the commencement of the Academic Session, i.e., on or after 29th July, 2026, the request for withdrawal along with the prescribed refund application form (Annexure–VI) shall be submitted to the Director of the NIFT Campus where the candidate has been provisionally admitted.

Such requests shall be processed in accordance with the applicable rules and refund policy of the Institute.
