



After successful Login, a Dashboard page will appear on the screen, click on the "Register for Counseling" button as shown in the screenshot below:




The Application Info page will appear on the screen. Click on the Educational Detail tab on the left side menu.

Please note NRI sponsored seats where applicable is a separate and deliberate choice.





How to pay the Application Fees?



Once payment is made by the candidate following options are available on the dashboard

Upgrade Option: You are automatically eligible for the upgrade option if you do not opt for the Slide OR Freeze option. If admission to an academic program of better/ higher preference in any campus is offered then a new seat will be allocated to you. Else, you will continue with the currently accepted academic program. In this case, you will be considered in subsequent rounds of counselling.

Slide Option: Opt this If you accept the offered seat and if admission to an academic program of better / higher preference is offered within the same campus then a new seat will be allocated. In this case, you will be considered in subsequent rounds of counselling for only the Campus offered and accepted in subsequent rounds of counselling.



If you want to be considered for higher preferences in the same allotted campus, select 'Admission Seat Slide' option.






If you are satisfied with the seat allocation and do not want to change your allotted seat.click on the Admission Seat Freeze icon.




Once you freeze your allotted seat it will be frozen and you will not be considered in subsequent seat allocation rounds







